Flash floods unleashed by

heavy rainfall have wreaked havoc across Balochistan. Floods and rains claimed precious human lives, destroyed standing crops, killed livestock, and swept away bridges, dams, and roads throughout the

The 30-year average rainfall record has been broken

A statement from the climate change ministry said that the 30-year average for rainfall in Balochistan and Sindh had been broken. In Balochistan, the destruction caused by floods is beyond imagination.

The Balochistan government has declared an emergency in 26 out of a total of 34 districts of Balochistan. Some deputy



commissioners have performed well when it comes to rescue and relief operations. Pakistan Army and Frontier Corps have extended all-out support to the provincial government in evacuating the stranded people.

Above all, Commander 12-Corps Lieutenant General Sarfaraz Ali and other military officers embraced martyrdom in the relief and rescue opera-tion in Lasbella.

The Balochistan government should take the lead

Nevertheless, it is the core responsibility of the Balochistan government to get a leading role in the rescue and relief operations. The CM and cabinet members should come




ISLAMABAD: Electricity is likely to become more expenas the Central Purchasing Agency (CPPA) has filed an application with NEPRA seeking power tariff increase by Rs4.69 paise per

unit.

According to details, the Central Power Purchasing Agency (CPPA) has filed a request in National Electric Power Regulatory Authority (NEPRA) to increase the price of electricity by Rs4.69 per unit on account of the monthly fuel adjustment of July.

The NEPRA will hear the request of CPPA on August 31. The increase will impose an additional burden of more than Rs65 billion on consumers.

CPPA says that in July 5.17 percent of electricity vas generated from water, 2.74 percent from coal, .46 percent from diesel, 5.42 percent from furnace

According to CPPA, the cost of electricity generated by diesel was Rs27.88 per unit, electricity generated from furnace oil was Rs35.69 paisa per unit.CPPA said that the reference cost for July was set at Rs6.28 paise per unit, the production cost of electricity production cost of electricity was Rs10.98 paise per unit, thus a total of 13 billion 76 crore units of elec-tricity were generated in July.INP

Floods expose construction quality of dams in Balochistan

Flash floods unleashed by torrential rains exposed the construction

Flash floods unleashed by torrential rains exposed the construction quality of dams across Balochistan. Heavy rainfall wreaked havoc in Quetta and other parts of Balochistan recently. Floods swept away dozens of small delay and check dams in different parts of the province.

Over the years, the provincial and federal governments constructed hundreds of dams to check the wastage of rainy water. Successive governments merely celebrated the completion of projects rather than focusing on the construction quality of dams. Although, the dams and lakes constructed by British colonial rulers in different parts of Balochistan are still intact even after more than a century.

Breaching of dams puts human lives at peril
Breaching of dams not only failed to save rainy water rather it also put human lives at peril in Pishin, Barkhan, Lasbella, Kohlu, Killa Abdullah, Killa Saifullah and other districts of the province. Rains-related incidents have claimed 65 lives till the filing of this editorial. This is simply disastrous and a failure from all concerned quarters.

Flash floods also swept away poorly constructed roads and standing

Flash floods also swept away poorly constructed roads and standing crops in various parts of the province. This all needs a thorough investigation. Irrigation and Communication Works (C&W) departments are

known for commission and corruption. Commission, corruption a common word in C&W and Irrigation

This is a good opportunity for those at the helm of affairs to make sure transparency in the utilization of funds by the two departments. Since word commission is an open secret in the two departments, the Chief Secretary of Balochistan should form a high-powered committee comprising committed and honest retired and serving officers to probe into

The quality of construction of roads in Quetta and all districts of Balochistan should also be probed to improve socio-economic conditions. The irony with Balochistan is that first the province has meager resources and second they too are ruthlessly used/ swallowed.

Chief Minister Balochistan, Mir Quddus Bizenjo and his coalition part-

ners must go beyond words and launch an inquiry into the breaching of dams and damage to roads.

In choppy waters

Pakistan is wobbling in choppy waters, literally as well as figuratively. A natural disaster has overlapped a politi-cal crisis. There is a growing sense of foreboding about what may happen during the next few days. Dark clouds are hovering on the horizon. Again, politi-cally and meteorologi-

Because of how popular imagination is hooked on politics, not enough attention is paid by the media to the rain emergency that has deepened during the past few weeks. There have been reports in the main news bulletins but almost no mention is made of the misery of millions of citizens across vast terrains in talk shows and other

regular features.
And just when the magnitude of the calamity was beginning to break into the consciousness of our opinion makers, the Shahbaz Jill episode nas sudden ly become the nation's foremost preoccupation. For once, this would be a legitimate distraction, considering its possible political fallout. The dramatic developments that were played out on Friday are likely to become a catalyst in the ongoing power struggle.

In many ways, the ini-tiative rests with Imran Khan to take decisive political action. He has certainly been building up the tempo with large

public rallies and the show staged in Lahore on the eve of the Independence Day must have boosted the confidence of his supporters. It was a well-designed political extraores. political extravaganza.

But what happened on Friday could not have been a part of any planned strategy. After Shahbaz Gill's arrest for allegedly inciting allegedly inciting mutiny among armed forces in a statement telecast live by ARY, Imran Khan himself and other PTI leaders were cautiously distancing themselves from the remarks made by the party's most strident spokesperson. In the Senate, PTI leader Faisal Javed was categorical in repudiating the stance that had been adopted by Shahbaz Gill.All this changed on Friday after video recordings of how Imran Khan's chief of staff was brought to court became viral. There he was visibly in ain and crying out for his respiratory mask. A clip was shared by the PTI's official Twitter account, describing the scene as "heartbreaking".Irrespective of a contradictory statement of the Islamabad police and partisan assertions that Shahbaz Gill had been certified as healthy in a medical report, the visuals and allegations made by PTI leaders seriously raised the issue of torture. It is

government would have to deal with against the backdrop of rising ten-

Imran Khan took the charge of torture to another level and said in a tweet: "All the pic-tures & videos show clearly Gill was tortured both mentally & physi-cally incl sexual abuse – most too gruesome to relate". He immediately went into action and drove to the Pakistan Institute of Medical Sciences (Pims) to see Shahbaz Gill, where the PTI leader was sent by the sessions court.

Not allowed to meet his chief of staff, he announced protest rallies in support of Shahbaz Gill across the country, with he himself leading one in Islamabad on Saturday evening. Hence the threat of public disorder has become real. That Punjab is now governed by the PTI, care of Parvez Elahi, may strengthen Imran strengthen hand to some Knan s extent. Yet, there is considerable ambiguity about how the powers that be will deal with the unfolding scenario.

Already, proceedings against Imran Khan have been initiated with reference to the Election Commission Pakistan's verdict on foreign funding and the Toshakhana case. On Friday, the ECP issued notices of Imran Khan, Fawad Chaudhry and Asad Umar for making

"intemperate and contemptuous remarks" against the electoral

watchdog.

With a renewed focus on this fateful political conflict, the rain disaster and massive disruption in the lives of a large number of people will remain somewhat in the background. But there is one incident that intertwines the rain dis-aster with the current political upheaval. Something seems mys-terious about this connection and how it is evolving. I am referring to that tragic helicopter crash in which we lost six army personnel, including Lt-Gen Sarfraz Ali. This crash took place in Lasbela, a district of Balochistan on the first day of this month. Now, this was a flood relief operation and bad weather was said to be a reason for the accident.

Strangely, this heli-copter crash prompted a negative campaign in the social media of such a nature that the military authorities had to take cognisance. In a press conference this week, Defence Minister Khawaja Asif blamed Imran Khan for "patron-ising" his Chief of Staff Shahbaz Gill and others for launching this campaign. In any case, an extensive investigation is in progress and some arrests have been made.

uetta is the capital city of Baluchistan, the largest province of the Is I a m i c Republic of Pakistan. It is located at an altitude of 1,680 m between the strategically important Bolan and Khojak passes Bolan and Khojak passes on the route to Afghanistan. The town and suburbs have grown tremendously in the last 20 years, and hold now an estimated population of 1.2 million. Inadequate wastewater and solid waste disposal, storm water drainage and flood control seriously affect

water drainage and flood control seriously affect the existing water resources as well as the urban environment. Sanitation refers to public health conditions related to clean drinking water and 'treatment and disposal of human excreta and sewage. Preventing human contact with feces is part of sanitation, as is hand washing with soap. Sanitation syswith soap. Sanitation systems aim protec

ing a clean environment that will stop the transmission of disease, especially through the fecal oral route. For example, diarrhea, a main cause of malnutrition and stunted growth in children, can be reduced through adequate sanitation. The unpleasant smell of the sewage water dismayed over prevailing unhygienic sanitary conditions in Quetta. The garbage dumped into the drains daily has fully choked the already ineffective sewerage system. Sariab Road, Sabzal Road, Spiny Road, Kasi Road, Mizan Chowk, Prince Road, Musa Colony, Wahdat Colony and Nawan Killi were among the areas where sewage water had accumulated due to choking of the drainage system. Only a few areas like Satellite Town, Shahbaz Town, Jinnah Town and Model Town were established with some planning. already ineffective sew-

with some planning. There are 315 slums and underserved areas located in 44% of the 50 Union Councils of Quetta city. 57% slums are not found in any of the government records. Quetta city has 2 Million population out of which 35% lives in slums

underserved areas.

13% residents of these disadvantaged areas are temporarily displaced either in the province or are of other nationalities (mostly Afghans). The provincial capital of Balochistan generates over 700 tons of solid waste every day, but the administration is only capable of disposing of around 300 tons of it. The rest of the sewage meanaround 300 tons of it. The rest of the sewage meanders in the area, while some of it is used to grow vegetables. As the sewerage system is clogged, dirty water accumulated on the streets. People found it

difficult to walk in most areas like Mikangi Road, Imdad Chowk, Mission Chowk, Korai Gawalmandi Browri and Road, Chowk,

Increasing the number of people with access to basic sanitation facilities and the amount of fecal waste amount of fecal waste effectively captured and effectively captured and treated on-site, or collected, transported, and treated offsite. Improving the ability of educational and health systems to manage sanitation and hygiene facilities in institutions and affordability and availability of sanitation products and services. Increasing the number of people with safely managed sanita-

safely managed sanita-tion services, handwashing with soap at critical times and the rate of safe management of house-hold drinking water.

Demographic engineering

Indian authorities have recently permitted temporecently permitted temporary residents in Indian Illegally Occupied Jammu and Kashmir (IIOJK) to register as voters. This is yet another attempt by the Indian government to change the demographic features of Kashmir. This move follows the

promulgation of a new domicile law after the repeal of Article 370 of the Indian constitution, revoking the special sta-tus of the state and its bifurcation into two territories. The announced measure is likely to add 2.5 million more voters, which the local popula-tion fears would allow the BJP government to alter the demographics of the region.
It is a sinjster move to

convert the Muslim majority into a minority in due course of time and has rightly been rejected and condemned by Pakistan. The action constitutes the blatant viola-tion of the Geneva Convention and the UN resolutions on the Kashmir dispute. After the end of World War II, as a consequence of the initiative taken by the International Committee of Red Cross, the Diplomatic Conference for the Establishment of International Convention for Protection of Victims of War was held in Geneva, which adopted the fourth Geneva Convention on 12 August 1949. It is one of the four treaties of the Geneva

Conventions. While the first three

conventions dealt with combatants, the fourth Geneva Convention was the first to deal with humanitarian protections for civilians in a war zone. Currently, 196 countries are party to the 1949 Geneva Conventions.

In 1993, the UN Security Council adopted a report from the secregeneral and a commission of experts which concluded that the Geneva Conventions had passed into the body of customary international law, thus making them binding even on non-sig-natories to the conventions whenever they engage in armed conflicts.

Article 27 of the eneva IV states: Geneva IV states: "Protected persons are entitled, in all circumstances, to respect for their persons, their honour, their family rights, their religious convic-tions and practices, and their manners and cus-toms. They shall at all times be humanely treated, and shall be protected especially against all acts of violence or threats thereof and against insults and public curiosi-

Article 49 of the Geneva IV says: "The Occupying Power shall not deport or transfer parts of its own civilian population into the territory it occupies." Article 32 of the convention adds: "The High Contracting Parties specifically agree that each of them is prohibited from taking any measure

of such a character as to cause the physical suffering or extermination of protected persons in their hands. This prohibition applies not only to murder, torture, corporal punishments ... but also to any other measures of brutality by civilian or military agents."

brutality by civilian or military agents."
Giving voting rights to non-residents and allowing people from the Indian mainland to buy property in IIOJK is in breach of Article 49 of the fourth Geneva Convention Convention.

Indian security forces in IIOJK are the occupying power by all definitions since Kashmir's fate, as per UN resolutions, is to be decided through a plebicaite held through a plebiscite held under the auspices of the world body, a position which the UNSC has reiterated in its three infor-mal meetings after the

Modi regime revoked the state's special status.

After the scrapping of Article 370 of the Indian constitution, the entire population of Kashmir is under siege, and they have been denied contact with the outside world; there is a complete lockdown in the valley, and people are not even given access to mosques. International media. human rights organiza-tions like Amnesty International and even UN Human Rights commission in its reports has corroborated blatant violations of human rights in IIOJK. The discovery of mass graves at 38 sites also lends currency to the inhumane treatment of

the local population by

Indian security forces.
Through the foregoing actions India has not only torn asunder the fourth Geneva Convention but also pummelled the UN resolutions with regard to the plebiscite and breached international

law with impunity.

It is indeed regrettable that neither the UN nor the big powers have shown real interest in stopping India in its tracks and resolving the Kashmir conflict as per the UN resolutions. Their indifference to the devel-opments taking place in the valley and the fallout of those provocative measures is encouraging hegemonic Indian designs in the region.

India is being ruled by a diehard follower of the

supremacist RSS ideology of Hindutva, which takes inspiration from Nazism. It has already started showing its ugly face in the form of enhanced Indian hostility towards Pakistan. Indian leaders have repeatedly threatened Pakistan of dire consequence, and on February 2019, India made its intentions clear when it sent planes to bomb imagined terrorist camps in Balakot, ostensibly in retaliation for the Pulwama incident. It is interesting to note that an Indian journalist close to the BJP regime later revealed that the

elections and find an excuse to take action

against Pakistan.

India has also been supporting insurgency in Balochistan and acts of terrorism throughout the country as corroborated by the revelations made by the captured Indian

spy Kulbhushan Jhadav.
Is it not a pity that a state which has shown no respect for UN resolu-tions, international law and the fourth Geneva Convention is being supported for a permanent seat in the Security Council, besides prop-Council, besides propping it up as a regional superpower through transfer of nuclear technology and NSG waiver in complete violation of the Nuclear Non-Proliferation Treaty?

They fail to realize that any such eventuality would lead to perennial instability in the region and foreclose any chance of resolution of the Kashmir dispute.

Animal cruelty in Pakistan Sved Mohammad Ali "he indiffer-ence, callous-

ness, and contempt that so many people exhibit toward animals is evil first because it results in great suffering in ani-mals, and second because it results in an incalculably great impoverishment of the human spirit." I did not pen these words. Albert Einstein did. Islam also forbids treating ani-mals cruelly or killing them except for food. Zabiha rules stipulate how an animal to be slaughtered must not be mistreated or caused undue pain. Yet, animal cruelty is rampant and exists in varied forms in

countries like ours.

We live in a country where political leaders have been known to hold political rallies with caged and chained lions, and where animals like turtles given away as party favours at chil-dren's birthdays. Many well-to-do people pay a lot of money to purchase expensive cats, dogs, or birds but treat them callously. Cruelty towards animals is not the reserve of rich people only. Cruelty to animals especially donkeys, horses and mules is also widespread. These animals are overworked, under-fed, and harshly beaten by

their owners. Some recent attempts at humane dog population management and mass vaccinations in Karachi have dissipated. Instead,

the recent uproar follow-ing the negligence of animal owners and attacks by guard dogs on pedes-trians in Karachi trians in Karach unleashed another unwarranted attacks on dogs all over the country. Several neighbourhoods started instigating municipal organisations to shoot stray dogs on sight. Use of strychnine poison was once again allowed to poison dogs.

There is a general absence of adequate laws related to animal welfare and animal slaughter and

and animal slaughter, and the existing laws that exist are not adequately implemented. Pakistan's Prevention of Cruelty to Animals Act (1890) aims to protect many animals, including draught animals. This law is however outdated and does not reflect the prevalent sci-entific, cultural, or commercial compulsions per-taining to animal welfare. It is time to update this law to protect both pet and wild animals, to institute mechanisms for their care, and define conse-quence for those who are neglectful towards ani-

mals.
It is encouraging that the Halal Authority Act (2015) has not only mandated humane treatment of animals throughout the slaughter process, but also prohibited animals from seeing one another being slaughtered. However, there has been little implementation of

this law. While animal abandon-

ment is illegal in Pakistan, there is scant regulation on how animal owners should care for their animals. Moreover, zoos across Pakistan are zoos across Pakistan are notorious for their poor conditions. Prompted by international criticism over the Islamabad zoo's maltreatment of the ele-phant, Kaavan, the Islamabad High Court issued an unprecedented ruling last year. It ordered that the entire zoo of over that the entire zoo of over four hundred animals to be closed and all the animals within it to be transferred to appropriate wildlife sanctuaries in the short period of two months. The rush to empty the zoo caused the death of a pair of lions which passed away, two days apart, during their transfer from the zoo to a transfer from the zoo to a farmhouse in Kasur city instead of a sanctuary as had been directly by the court. Pakistan also urgently

needs to enact legislation detailing specific welfare requirements for the rearrequirements for the rearing of farm animals during distinct phases of rearing, transport, and slaughter. Such requirements must be legally binding and species-specific and aligned with international animal welfare standards. Regular inspections of farms and inspections of farms and slaughter establishments would have to be carried out with a special focus on animal welfare or the situation on the ground will not change for the

ISLAMABAD: As of August 20, as many as 728 people have died due to recent rains and floods across the country Sunday reported citing a report of the National Disaster Management Authority (NDMA).
The NDMA has

released the details of the loss of life and property due to rains. Among those who died the most were men, whose number was 309, the NDMA report

The majority of the people who died were from Balochistan, whose number was 207, the report added.

At the same time, the number of people killed due to recent rains in Sindh has reached 177, whereas, the number of people killed in Khyber Pakhtunkhwa was record-

Collectively, as many as 309 men, 156 women and 263 children have

lost their lives across the country due to recent rains and floods.

Whereas, the total number of people who were injured across the country from June 14 to August 20 was recorded at 1.291.

The majority of people who were injured in rain and flood related incidents belonged to Sindh,

whose number was 701.

Besides, 300 people were injured due to rains in Punjab, 81 in Balochistan, 186 in Khyber Pakhtunkhwa and 19 in AJK.

Apart from the human loss, as many as 31,047 houses were completely destroyed while 85,724 houses were damaged across the country in rains and floods.

More than 503,000 catthe country, whereas, 2866.9km roads in the country were damaged. The shops were also not spared by the torrential rains and flash floods, as 17 shops were damaged in AJK while 32 shops were damaged in Sindh.

As many as 103 districts across the country have been affected by the recent rains and floods. Among the affected disricts, four are in Balochistan and as many in GB. Whereas, communication roads are blocked in Khyber Pakhtunkhwa.

them by communicating with the other plane's TCAS. A similar incident occurred on 26 July when two Pakistan International Airlines (PIA) airplanes closely avoid-ed a midair crash while flying on the same air route and altitude over Iranian territory near UAE airspace. The incident was

caused by the purported negligence of the Iranian Air Traffic Controller which had (ATC) cleared the same altitude for both the airplanes, positioning them in close proximity to each other.

One of them, a Boeing 777, was fly-ing from Islamabad to Dubai, while the other, an Airbus A320, was headed from Doba to Doha Peshawar, as per the sources. When they were found to be dangerously close to each other, one was instructed to ascend and the other was told to descend in accordance with the s t a n d a r d

"Apart from forex inflows and outflows, the monetary policy decision will be instrumental to gauge the rupee's future direction. The market is looking at Monday's meeting," the trader added.

The government lifted a ban on the import of non-essential and luxury goods to meet a condition of the International Monetary Fund (IMF) ahead of the board's meeting later this month to revive the loan programme. However, it announced imposition of heavy duties on completely built units cars, mobile phones, and electronic appliances to discourage imports.
