



ISLAMABAD: Defence Minister Khawaja Muhammad Asif Friday criticised PTI Chairman Imran Khan for his incessant whining on the matter of

"Imran Khan has been using [abusive] language since his ouster. Before, Khan would say that he and the [establishment] are on the same page. During his time in power, his hugs would not end with them and now, he is abusing them," Asif said.

Addressing a joint press conference with Minister for Information and Broadcasting Marriyum Aurangzeb, Planning Minister Ahsan Iqbal, Minister of State for Petroleum Musadik Malik and Special Assistants to the Prime Minister Tariq Fatemi and Attaullah Tarar, the defence minister added that the PTI chief's only problem is regaining power. He added that Pakistan's state cannot function at the behest of Khan's personal wishes.

QUETTA VOICE Editor Asim Khan Power outages in Balochistan

More than 20 hours of load shedding in rural Balochistan is a stark reminder of poor governance and incompetent officers at the Quetta Electric Supply Company (QESCO). Despite repeated assurances, the Company is yet to ensure power supply to remote areas of the province, which covers half of the country in terms of area.

Growers action committee has staged a series of protest demonstra-tions to mount pressure on the QESCO for acceptance of its demands. The farmers across the complain about huge financial losses because of power outages. Prolonged and unannounced load shedding has become a common practice in every summer. The farmers complain that low or no power supply has severely affected standing crops in various parts of Balochistan. Majority of the people in this part of the country are financially dependent on agriculture sector, which has also been severely affected by drought hit like situation. QESCO Chief Engineer Karim Jamali while speaking to this daily revealed about a shortfall of 1000 megawatts in Balochistan. He also blamed the growers and domestic consumers for not paying their bills. He revealed that there are more than 4 trillion rupees outstanding in Balochistan against growers, government departments and domestic consumers.

However, the growers disagree and link the payment of bills with

availability of power supply.

Indeed, power theft is on the rise. Corrupt elements within the QESCO have cemented good ties with growers and other influential people. This has actually caused a loss of billions of rupees to the company. It is common saying that grease the palm of QESCO officials and then get uninterrupted power supply. The issue is from both sides. The growers also pay a nominal amount of Rs. 10000 at per tube well and then pump the under ground water non stop. The Balochistan government must take up the power shortfall issue with the federal government to address this issue once and for all ment to address this issue once and for all.

QESCO should first launch a crack down against its own corrupt elements to ensure the recovery of outstanding amounts. Only then, the elements involved in massive power theft can be brought to book.

In choppy

Pakistan is wobbling in choppy waters, liter-ally as well as figura-tively. A natural disaster has overlapped a politi-cal crisis. There is a growing sense of foreboding about what may happen during the next few days. Dark clouds are hovering on the horizon. Again, politi-cally and meteorologi-

Because of how popular imagination is hooked on politics, not enough attention is paid by the media to the rain emergency that has deepened during the past few weeks. There have been reports in the main news bulletins but almost no mention is made of the misery of millions of citizens across vast terrains in talk shows and other regular features.

And just when the magnitude of the calamity was beginning to break into the consciousness of our opinion makers, the Shahbaz mii episode nas sudden ly become the nation's foremost preoccupation. For once, this would be a legitimate distraction, considering its possible political fallout. The dramatic developments that were played out on Friday are likely to become a catalyst in the ongoing power struggle.

In many ways, the ini-tiative rests with Imran Khan to take decisive political action. He has certainly been building up the tempo with large

public rallies and the show staged in Lahore on the eve of the Independence Day must have boosted the confidence of his supporters. It was a well-designed political extravaganza.

But what happened on Friday could not have been a part of any planned strategy. After Shahbaz Gill's arrest for allegedly inciting mutiny among armed forces in a statement telecast live by ARY, Imran Khan himself and other PTI leaders were distancing cautiously themselves from the remarks made by the party's most strident spokesperson. In the Senate, PTI leader Faisal Javed was categorical in repudiating the stance that had been adopted by Shahbaz Gill All this changed on Friday after video recordings of how Imran Khan's chief of staff was brought to court became viral. There he was visibly in un and crying out for his respiratory mask. A clip was shared by the PTI's official Twitter account, describing the scene as "heartbreaking".Irrespective of a contradictory statement of the Islamabad police and partisan assertions that Shahbaz Gill had been certified as healthy in a medical report, the visuals and allegations made by PTI leaders seriously raised the issue of torture. It is something the federal

to deal with against the backdrop of rising tensions.

Imran Khan took the charge of torture to another level and said in a tweet: "All the pic-tures & videos show clearly Gill was tortured both mentally & physi-cally incl servel abuse cally incl sexual abuse most too gruesome to relate". He immediately went into action and drove to the Pakistan Institute of Medical Sciences (Pims) to see Shahbaz Gill, where the PTI leader was sent by the sessions court. Not allowed to meet

his chief of staff, he announced protest rallies in support of Shahbaz Gill across the country, with he himself leading one in Islamabad on Saturday evening. Hence the evening. Hence the threat of public disorder has become real. That Punjab is now governed by the PTI, care of Elahi, Parvez may Imran strengthen to some Knan s extent. Yet, there is conambiguity siderable about how the powers that be will deal with the unfolding scenario.

Already, proceedings against Imran Khan have been initiated with reference to the Election Commission Pakistan's verdict on foreign funding and the Toshakhana case. On Friday, the ECP issued notices of Imran Khan. Fawad Chaudhry and Asad Umar for making

"intemperate and contemptuous remarks" against the electoral watchdog.

With a renewed focus on this fateful political conflict, the rain disaster and massive disruption in the lives of a large number of people will remain somewhat in the background. Article 27 of the eneva IV states: Geneva Protected persons are entitled, in all circum-stances, to respect for their persons, their honour, their family rights, their religious convictions and practices, and their manners and cus-toms. They shall at all times be humanely treated, and shall be protected especially against all acts of violence or threats thereof and against insults and public curiosi-

Article 49 of the Geneva IV says: "The Occupying Power shall not deport or transfer parts of its own civilian parts of its own civilian population into the territory it occupies." Article 32 of the convention adds: "The High Contracting Parties specifically agree that each of them is prohibited from taking any measure of such a character as to cause the physical suffer-ing or extermination of protected persons in their hands. This prohibition applies not only to murder, torture, corporal punishments ... but also to any other measures of

any other measures of brutality by civilian or military agents."
Giving voting rights to non-residents and allow-ing people from the Indian mainland to buy property in IIOIK is in breach of Article 49 of the fourth Geneva Convention.

Indian security forces in IIOJK are the occupying power by all definitions since Kashmir's fate, as per UN resolutions, is to be decided through a plebiscite held through a plebiscite held under the auspices of the world body, a position which the UNSC has reit-erated in its three informal meetings after the Modi regime revoked the state's special status.

After the scrapping of Article 370 of the Indian constitution, the entire population of Kashmir is under siege, and they have been denied contact with the outside world there is a complete lock-down in the valley, and people are not even given access to mosques. International media, human rights organiza-tions like Amnesty International and even UN Human Rights commission in its reports has corroborated blatant violations of human rights in IIOJK. The discovery of mass graves at 38 sites also lends currency to the inhumane treatment of

the local population by Indian security forces.

actions India has not only torn asunder the fourth Geneva Convention but also pummelled the UN resolutions with regard to the plebiscite and breached international law with impunity.

Animal cruelty in Pakistan Syed Mohammad Ali

"he indifference, callousness, and contempt that so many people exhibit toward animals is evil first because it results in great suffering in ani-mals, and second because it results in an incalculably great impoverishment of the human spirit." I did not pen these words. Albert Einstein did. Islam also forbids treating ani-mals cruelly or killing them except for food. Zabiha rules stipulate how an animal to be slaughtered must not be mistreated or caused undue pain. Yet, animal cruelty is rampant and

exists in varied forms in countries like ours. We live in a country where political leaders have been known to hold political rallies with caged and chained lions, and where animals like turtles given away as party favours at chil-dren's birthdays. Many well-to-do people pay a lot of money to purchase expensive cats, dogs, or birds but treat them callously. Cruelty towards animals is not the reserve of rich people only Cruelty to animals especially donkeys, horses and mules is also widespread. These animals are overworked, under-fed, and harshly beaten by

their owners. Some recent attempts at humane dog population management and mass vaccinations in Karachi have dissipated. Instead,

the recent uproar following the negligence of animal owners and attacks by guard dogs on pedes-trians in Karachi unleashed another unwar-ranted attacks on dogs all over the country. Several neighbourhoods started instigating municipal organisations to shoot stray dogs on sight. Use of strychnine poison was once again allowed to poison dogs.

There is a general absence of adequate laws related to animal welfare and animal slaughter, and the existing laws that exist are not adequately implemented. Pakistan's Prevention of Cruelty to Animals Act (1890) aims to protect many animals, including draught animals. This law is however outdated and does not reflect the prevalent scientific, cultural, or commercial compulsions permercial compulsions per-taining to animal welfare. It is time to update this law to protect both pet and wild animals, to institute mechanisms for their care, and define consequence for those who are neglectful towards animals.

It is encouraging that the Halal Authority Act (2015) has not only mandated humane treatment of animals throughout the slaughter process, but also prohibited animals from seeing one another being slaughtered However, there has been little implementation of

While animal abandon-

ment is illegal in Pakistan, there is scant regulation on how animal owners should care for their animals. Moreover, zoos across Pakistan are notorious for their poor conditions. Prompted by international criticism over the Islamabad zoo's maltreatment of the elephant, Kaavan, the Islamabad High Court issued an unprecedented ruling last year. It ordered that the entire zoo of over four hundred animals to be closed and all the animals within it to be transferred to appropriate wildlife sanctuaries in the short period of two months. The rush to empty the zoo caused the death of a pair of lions which passed away, two days apart, during their transfer from the zoo to a farmhouse in Kasur city instead of a sanctuary as had been directly by the court.

Pakistan also urgently needs to enact legislation detailing specific welfare requirements for the rear-ing of farm animals dur-ing distinct phases of rearing, transport, and slaughter. Such requirements must be legally binding and species-spe-cific and aligned with international animal welfare standards. Regular inspections of farms and slaughter establishments would have to be carried out with a special focus on animal welfare or the situation on the ground will not change for the

Electricity transmission restored across country: Power

ISLAMABAD: After an almost day-long out-age, the Power Division on Friday said that electricity transmission and generation have been restored across the country adding that only rou-tine power load-shedding

is being carried. "Electricity transmis-sion and generation have been restored across Pakistan including restoration of full supply from national grid to Karachi," the division said in a statement.Earlier today, sources within the National Transmission and Despatch Company (NTDC) had said that the countrywide power crisis, caused due to an "acci-dental fault" in the nation-al grid, had not been controlled yet. Sources in the NTDC said that it was a major breakdown and could not be controlled even after 24 hours as the authorities have yet to identify the fault. The sources added that cities have been facing four hours of loadshedding while rural areas are suffering from a 12-hour-

long power outage. Meanwhile, power plants have not been fully energised and the country still faces a 4,500MW power shortfall while the frequency fluctuation is making things more com-

The electricity is being restored from the power plants slowly to the system, said the sources. They added that this is the 16th breakdown in the last 10 years.

Large parts of the country were in dark for more than 12 hours on Thursday after a fault was detected in the national grid's southern transmission system.

Energy Minister Khurram Dastagir said that an "accidental fault" triggered the breakdown and announced the establishment of a committee to probe the matter and submit a report within four days.INP


ISLAMABAD: The successful launching of a third power plant with a capacity of 330 megawatts on the indigenous Thar coal will help Pakistan to generate cheap electricity and reduce import bill to save foreign exchange reserves, WealthPK reports.

After the installation of the third plant, the total capacity of the plants on indigenous Thar coal has reached

According to National Electric Power Regulatory Authority (NEPRA), the per unit cost of electricity generated through Thar coal was Rs14.41 per unit in August 2022. The per unit cost of electricity generated from furnace oil is Rs35, imported coal Rs23.6 and high-speed diesel Rs27.8 per unit while the cost of per unit electricity imported from Iran is Rs20.94.

The earlier installed 660 megawatts power plant on Thar coal had created 3,000 jobs during construction and 4,300 jobs after it was made operational. The recently-approved projects will also generate a lot of jobs. Dr Athar Mansoor, an energy expert said in a podcast that presently Pakistan was not ready to make the transition to a sustainable energy system. It is evident that a transition is needed in Pakistan, but the country first requires to improve its economy as a huge amount of funds will be required to make the transition successful.

He said that Thar coal could be also converted into gas and liquid to utilise by other industries like cement



The majority judgment rejected the objections raised on the admissibility of the presidential reference, saying the court had already given answers to the objections in another case. The decision said that if the prime minister or chief minister lost confidence in the parliamentary party then he had to face a vote of no-confidence. A member voting against party directives was destructive to the parliamentary dem-ocratic system, the apex court added. The right of assembly members to express their opinion had also been protected in the lawyers' front case, the verdict said. Members of the Assembly could discuss, agree or dis-agree within the party on the issue of vote, however, when "it comes to the voting the situation would be differvote, however, when "it comes to the voting, the situation would be different". The judgment said the parliamentary party's instructions had to be followed while voting under Article 63A. It was argued that not counting the dissident member's vote would give rise to authoritarianism in the parliamentary party but "we didn't agree with the argument".
