government issued a notification regard to increasing the age limit for new candidates applying for government jobs a few days back. As per the notification, the government has given eight years extension in the age limit for fresh candidates.

Now candidates of 43 years of age can apply for government jobs in Balochistan, Sardar Abdul Rehman Khetran, Balochistan Minister Communication Works

Department announced. However, this relaxation is only for one year.

Age relaxed from July 1st to 30th of June 2023, the notification mentions. This notification gives more questions than answers. The reason behind the age relaxation for government jobs is obvious i.e. ministers, advisers and parliamentary secretaries coupled with friendly opposi-tion would merely adjust their supporters in government departments.

Thousands of jobs are lying vacant in Balochistan

Currently, thousands of vacancies are lying departments. Jobless youth of the province are tired of submitting their documents in every department. Since appointments on merit have become rare in Balochistan, therefore, candidates with no political back-ing or less influence cannot get jobs.

The government has already empowered the departments to recruit employees rather than testing services. Based on track record, testing services are not ideal but they have proved to be far better than departments when it comes to merit and transparency in terms of the recruitment

Under the new notification, employees would only serve for 17 years



The question arises that why age relaxation for candidates is only for a year. If the government has clear intention of recruiting those who have tired of submitting docu-

ments for jobs, then, the offer should not be for a limited period. The notification is controversial and debatable, when the retirement age is 60 years, then, fixing 43 years as the eligi-

FIA books Imran, other PTI leaders in connection with prohibited funding case

The Federal Investigation Agency (FIA) has booked former prime minister Imran Khan and other PTI leaders in connection with their party allegedly received prohibited funding, it emerged on Tuesday.

The case was filed by the state through FIA's Corporate Banking Circle in Islamabad. The first information report (FIR), a copy of which is available with Dawn.com, stated that Arif Masood Naqvi — the owner of the Wooton Cricket Limited — transferred "ill-gotten" money to a United Bank Limited (UBL) account registered under the name of the PTI.

"The purpose stated in the swift messages of the transactions is 'agreed transfer' to disguise the true nature, origin, location, movement and ownership of

nature, origin, location, movement and ownership of these funds. Arif Masood Naqvi is also the founder/owner of Abraaj Group, UAE, which collapsed in 2018. Arif Masood Naqvi lied about the performance of Abraaj's funds by inflating their value," the complaint added.

"Therefore, Dubai Financial Services Authority.

"Therefore, Dubai Financial Services Authority (DFSA) imposed penalties on two Abraaj Group companies for carrying out un-authorised activities in Dubai International Financial Centre (DIFC) and misusing investors' money. The regulator imposed penalties amounting to \$299.30 million on Abraaj Investment Management Limited and Abraaj Capital respectively."

It further said that Naqvi was also facing trials in the United Kingdom and the United States for defrauding

United Kingdom and the United States for defrauding investors.

The complaint named Imran Khan, Sardar Azhar Tariq Khan, Saifullah Khan Nyazee, Syed Yunus Ali Raza, Aamer Mehmood Kiani, Tariq Rahim Sheikh, Tariq Shafi, Faisal Maqbool Shaikh, Hamid Zaman and Manzoor Ahmad Chaudhary as signatories/beneficiaries of the PTI account in question.

"PTI submitted an affidavit of Arif Masood Naqvi before the Election Commission of Pakistan stating therein that all the amounts collected in the accounts of WCL were submitted into PTI's account in Pakistan. This affidavit has been proved to be false/forged as two more transactions were also made from WCL to two different accounts in Pakistan in May 2013."

The FIR further said that 12 CTRs/STRs had to be reported by the UBL management to the authorities but they failed to do so. "Chaudhary Shahid Bashir, the operation manager of UBL's Jinnah Avenue branch in Islamabad, facilitated these suspicious/illegal transactions by not reporting the aforesaid illegalities to the concerned authorities and also allowed Internet Merchant Acquiring Agreement changing the title of the account to Naya Pakistan". Flash floods unleashed by torrential rains exposed the construction quality of dams across Balochistan. Heavy rainfall wreaked havoc in Quetta and other parts of Balochistan recently. Floods swept away dozens of small delay and check dams in different parts of the province.

Over the years, the provincial and federal governments constructed hundreds of dams to check the wastage of rainy water. Successive governments merely celebrated the completion of projects rather than focusing on the construction quality of dams. Although, the dams and lakes constructed by British colonial rulers in different parts of Balochistan are

still intact even after more than a century.

Breaching of dams puts human lives at peril

Breaching of dams not only failed to save rainy water rather it also put human lives at peril in Pishin, Barkhan, Lasbella, Kohlu, Killa Abdullah, Killa Saifullah and other districts of the province. Rains-related incidents have claimed 65 lives till the filing of this editorial. This is simply disastrous and a failure from all concerned quarters.

Flash floods also swept away poorly constructed roads and standing crops in various parts of the province. This all needs a thorough investigation. Irrigation and Communication Works (C&W) departments are known for commission and corruption.

Commission, corruption a common word in C&W and Irrigation

This is a good opportunity for those at the helm of affairs to make sure transparency in the utilization of funds by the two departments. Since word commission is an open secret in the two departments, the Chief Secretary of Balochistan should form a high-powered committee comprising committed and honest retired and serving officers to probe into the breaching of dams.

The quality of construction of roads in Quetta and all districts of Balochistan should also be probed to improve socio-economic conditions. The irony with Balochistan is that first the province has meager resources and second they too are ruthlessly used/ swallowed.

Disaster displacement

In Pakistan, at least 33 million people have been forced to leave their homes. They are not fleeing any con-flicts, but they have been internally displaced by the effects of arguably the biggest global threat of the 21st century change.

Since the beginning of Pakistan's deadly floods in mid-June, at least 7.9 million people have been displaced, which is appalling to say the least. Even this could be a conservative estimate given the colossal damage the floods have caused.

Many of these people have lost everything - their homes, sources of livelihood, and prized belongings. These internally dis-placed people now face an uncertain future as national legislation or policy framework that can guarantee longterm protection and assistance to them.

This is regrettable as recent history in Pakistan is marked by a series of disaster-induced displacement crises. In 2010, massive floods displaced 11 million people, and another four million were displaced follow-ing the 2011 floods in

Sindh. A report pub-lished by Oxfam in 2019 revealed that the communities who permanently moved to Karachi from Badin, Thatta, and Sajawal after the 2010 floods were forced to settle on the outskirts of Karachi, where they lacked access to utilities. Nearly a decade on, they continue to live under poor and squalid conditions, which exemplifies the consequences of the lack of specific instruments that can offer long-term protection and assistance to peo-ple displaced by disas-

In 2021, the IDMC reported that a third of all disaster-induced displacements in 2020 occurred in the South Asian region, with Pakistan recording the third-highest number of those displacements India and Aighanistan Additionally, the World Bank forecasts continued to stress the forthcoming crisis of cli-mate change and internal displacement in South Asia. Hence, we were cognizant that disasters would continue to force millions to dislocate in Pakistan but did not grant legal recognition and rights to those dislocated during disasters or formucomprehensive policy frameworks to guide the national response in such situations.

At the international

level, the rights of internally displaced persons (IDPs) are covered under the Guiding Principles on Internal Displacement of the Office of the High Commissioner Human Rights. These principles serve to ensure that the rights of displacement-affected communities are not violated and guide national and international responses in such situations. However, it does not confer any obligation on the states, with authorities national having the primary duty to provide human-itarian assistance and protection to those in need in times of crisis. A number of states today have incorporated these principles into law or employed them as the basis for policy formulation. Some cases in point are Sri Colombia, Lanka, Burundi, Georgia, Armenia, Angola, Peru, Uganda, and the Philippines. In Pakistan, howev-

er, a legal limbo with regard to the recognition of the rights of disaster-induced IDPs continues to exist. At the same time, no specific policy document comprehensively addresses internal displacement or disasterinduced internal displacement specifically. Pakistan launched its first National Climate Change Policy (NCCP) in 2012 and its follow-Framework for Implementation Climate Change Policy (2014-2030) in 2014 both of which remain silent about disaster-

induced displacement. In March 2022, the Ministry of Climate Change launched an updated version of the NCCP. However, as welcome as this development was, the policy pays cursory attention to displacement by mentioning 'increased climate changeinduced migration' as one of Pakistan's vul-nerabilities to climate change threats. It does not specify policies or guide solutions, actions to durable including the return, resettlement, or reintegration of those forced to dislocate due to calamities. This gap is also evident in the National country's Disaster Reduction Policy and the National Disaster Management

Not since World War II has the threat to glob-al energy security been as severe as it is today.

Russia's brutal invasion of Ukraine and the consequent geo-eco-nomic war between the Kremlin and the West disrupted global gas markets at a scale unprecedented in recent history. The Kremlin's use of its power over energy markets as leverage - and Europe's efforts to wean itself off of Russian natural gas and avoid a massive shortage this winter triggering price hikes and rerouting flows around the world.

No one is left unaffected, even those who thought they had prepared for every eventuality. For example, Pakistan, which had secured several longterm natural gas import contracts to increase its energy security in recent years, has seen partners break those deals to send their gas to new clients offering to pay more. The coffers of both the developed and developing world are drained Meanwhile, the Kremlin is using the

global energy crisis it created to sustain its economy in the face of severe international sanctions. Now that Europe made it clear that it is finally – and perhaps much belatedly – ready to take the steps


