## Imran 'intentionally and deliberately' violated Elections Act, says ECP in detailed Toshakhana verdict

The Election Commission of Pakistan (ECP) found that PTI Chairman Imran Khan "intentionally and deliberately" violated the Elections Act, 2017, according to the detailed Toshakhana reference verdict released on Monday.

The ECP had disqualified Imran in the reference on Friday under Article 63(1)(p) for making "false statements and incorrect declaration". However, the full text of the 36-page order was not officially released, raising questions about whether it was really a unanimous decision and providing fodder to rumour mills to go into overdrive over the possibility of a dissenting note.

Imran filed a plea in the Islamabad High Court (IHC) on Saturday, challenging the ECP ver-

Saturday, challenging the ECP verdict.

The detailed verdict released today, a copy of which is available with Dawn com, said: "The respondent has intentionally and deliberately violated the provisions contained [in] sections 137 (submission of statement of assets and liabilities), 167 (corrupt practice) and 173 (making or publishing a false statement or declaration) of the Elections Act, 2017, who has made a false statement and incorrect declaration before the commission in the statement of assets and liabilities filed by him for the year 2020-21," elaborating that thus, Imran attracted disqualification under Article 63(1)(p).

Similarly, the ECP said he had "deliberately concealed the material facts" by not disclosing the details of his gifts in the statement of his assets and liabilities for the year 2018-19 or accounting for the sale proceeds.

The electoral watchdog reads that Imran made an "evasive

explained that the PTI chief had not

explained that the PTI chief had not provided details of the gift items and had also failed to add the details of the cash and bank account of the sale proceeds in the relevant Form-B sections.

"The amount allegedly received in his bank account does not commensurate with the assessed value of the gift items. Hence, the respondent has filed false statement and incorrect declaration, in material particular, for the financial year 2018-19," the verdict reads.

It explained that Imran had also not provided any explanation that

not provided any explanation that any non-disclosure was "uninten-tional, accidental or [a] bona fide

Regarding gifts purchased for the financial year 2019-20, the verdict

reads that Imran made an "evasive and ambiguous" statement in his written reply that the gifts for that period were further gifted on to others. However, the verdict said that the relevant Form-B section was left empty for this and there was no explanation provided.

"Therefore, it is established that he has deliberately concealed material facts and has submitted [a] false declaration of his assets and liabilities, in particular material. liabilities, in particular material, which entails serious consequences under the Constitution and law,"

As a result, the ECP said it was of the "considered opinion" that Imran stood disqualified, ceased to be an MNA and had also committed an "offence of corrupt prac-

tices" under the relevant Elections Act sections for "false statements and incorrect declaration"

Regarding its jurisdiction in the case, the ECP quoted relevant case law and verdicts to justify its role in the Toshakhana reference. It pointed out that the record of gift items received was maintained by the Toshakhana and the electoral watchdog was only limited to scrutinising the statement of assets and liabilities.

"It was the obligation of the respondent to declare complete details of assets whether in [the] shape of gifts or amount, including transfer of any assets to any person during the financial year, in the annual statement of assets and liabilities along with details and its cost value in column number 2 and 3 of Form-B (remarks).

"The commission has the juris-diction to incurrent any matter or

3 of Form-B (remarks).

"The commission has the jurisdiction to inquire into any matter or objection raised by any person, including a reference from [National Assembly] speaker against any member of the parliament or an assembly regarding concealment, false or misdeclaration in the statement of assets and liabilities after 120 days," the verdict reads.

Quoting case law, the ECP contended that it had the "exclusive jurisdiction" to adjudicate on the issue of a lawmaker's disqualification if received from the NA speaker or Senate chairman in terms of Article 63(2) and to decide the referred question under Article 63(3) of the Constitution, adding that it was also therefore, "competent" to judge in the Toshakhan instant matter.

instant matter. The reference was filed in August against Imran by the coali-tion government, for "not sharing details" of Toshakhana gifts and proceeds from their alleged sale. Lawmakers from the Pakistan Democratic Movement — the ruling alliance — had submitted the reference to NA Speaker Raja Pervaiz Ashraf, who had subsequently forwarded it to Chief Election Commissioner (CEC) Sikander Sultan Raja for further action

Established in 1974, the Tosha-khana is a department under the administrative control of the Cabinet Division and stores precious gifts given to rulers, parlia-mentarians, bureaucrats, and offi-cials by heads of other govern-ments and states and foreign digni-

taries.

According to Toshakhana rules, gifts/presents and other such materials received by persons to whom these rules apply shall be reported to the Cabinet Division.

However, the PTI, while in government, had been reluctant to disclose details of the gifts presented to Imran since he assumed office in 2018, maintaining that doing so would jeopardise international ties, even as the Pakistan Infor-mation Commission (PIC) ordered it to do so.

But later, in a written reply sub-mitted to the ECP on September 8, Imran had admitted to selling at least four presents he had received during his tenure as the prime min-

The former premier, in his reply, had maintained that the sale of the gifts that he had procured from the state treasury after paying Rs21.56 million fetched about Rs58m. One of the gifts included a graff wristwatch, a pair of cuff links, an expensive pen and a ring while the other three gifts included four

The reference against Imran was filed by MNA Barrister Mohsin Nawaz Ranjha carrying signatures of lawmakers Agha Hassan Baloch, Salahudeen Ayubi, Ali Gohar Khan, Syed Rafiullah Agha and Saad Waseem Sheikh and it was subsequently forwarded to CEC Raia.

In their disqualification reference, MNAs from the ruling alliance included documentary evidence to corroborate their claims against the ex-premier and sought his disqualification under Sections 2 and 3 of Article 63 of the Constitution, read with Article



Article 62(1)(f) says: "A person shall not be qualified to be elected or chosen as a member of Majlis-e-Shoora (Parliament) unless [...] he is sagacious, righteous and non-profligate, honest and ameen, there being no declaration to the contrary by a court of law."

profigate, nonest and ameen, there being no declaration to the contrary by a court of law."

Article 63(2) says: "If any question arises whether a member of Majlis-e-Shoora (Parliament) has become disqualified from being a member, the Speaker or, as the case may be, the Chairman shall, unless he decides that no such question has arisen, refer the question to the Election Commission within thirty days and should he fail to do so within the aforesaid period it shall be deemed to have been referred to the Election Commission."

While, Article 63(3) reads: "The Election Commission shall decide the question within ninety days from its receipt or deemed to have been received and if it is of the opinion that the member has become disqualified, he shall cease to be a member and his seat shall become vacant." Web Desk

jobs a few days back. As per the notification, the government has given eight years extension in the age limit for fresh candidates.

Now candidates of 43 years of age can apply for government jobs in Balochistan, Sardar Abdul Rehman Khetran, the Balochistan Minister for Communication and Works Department announced. However, this

for Communication and Works Department announced. However, this relaxation is only for one year.

Age relaxed from July 1st to 30th of June 2023, the notification mentions. This notification gives more questions than answers. The reason behind the age relaxation for government jobs is obvious i.e. ministers, advisers and parliamentary secretaries coupled with friendly opposition would merely adjust their supporters in government departments.

Thousands of jobs are lying vacant in Balochistan

Currently, thousands of vacancies are lying vacant in various departments. Jobless youth of the province are tired of submitting their documents in every department. Since appointments on merit have become rare in Balochistan, therefore, candidates with no political backing or less influence cannot get jobs.

The government has already empowered the departments to recruit employees rather than testing services. Based on track record, testing services are not ideal but they have proved to be far better than departments when it comes to merit and transparency in terms of the recruit-

Under the new notification, employees would only serve for 17 years. The question arises that why age relaxation for candidates is only for The question arises that why age relaxation for candidates is only for a year. If the government has clear intention of recruiting those who have tired of submitting documents for jobs, then, the offer should not be for a limited period. The notification is controversial and debatable, when the retirement age is 60 years, then, fixing 43 years as the eligibility for applying for government jobs is beyond comprehension.

It means, the fresh recruited employees would only serve for 17 years and then their retirement would approach fast. The government has to review its decision since the province need young energetic and educated manower to run the affairs of the province.

According to

Indeed, the atmosphere's share of carbon dioxide—the planet's chief climate change contributor—has risen by 46 per cent since preindustrial times. al times.

The burning of fos-sil fuels like coal, oil, and gas for electricity, heat, and transporta-tion is the primary source of human-generated emissions. A second major source is a deforestation, which releases sequestered (or stored) carbon into the air. It's estimated that logging, clearcut-ting, fires, and other forms of forest degradation release an average of 8.1 billion metric tons of carbon dioxide per year, accounting for more than 20 per cent of all global CO2 emissions. Other human activities

that generate air pollu-tion include fertilizer use (a primary source of nitrous oxide emisof nitrous oxide emissions), livestock production (cattle, buffalo, sheep, and goats are major methane emitters), and certain industrial processes that release fluorinated gases. Activities like agriculture and road construction can also construction can also change the reflectivity of the earth's surface, leading to local warm-

ing or cooling.

As little as six months ago, I was feeling unhappy every morning, bordering on restlessness and flirting with sadness. What turned things around and is this happi-

Six months ago, I was on paternity leave and had made big plans to pursue long term professional goals that I never had a chance to pursue because of my full time day job. I thought the extra time I had on paternity leave would allow nity leave would allow me to pour myself into those goals but week after week, I was literally doing nothing to move the needle on that front Instead, I was finding happiness in spending time with my daughter, wife and parents. As well as the joy of doing noth-ing. But I was trying to fight this feeling, rather than embrace it.

All my life, being a type A personality, happi-ness was married to my professional life. The paternity leave was a strange window into realising it's possible to be unhappy professionally but happy personally. Perhaps this sounds obvi-ous to most people but it was a profound realisa-tion for me. I'm also the kind of person who likes to reinvent his life every few years and by that I few years and by that I mean change everything Originally, I had planned to use the paternity leave

Fluorosilicates, fluor aluminates, and other com-plex fluorine salts are used to produce hydro-fluoric acid and treat

jected to reach US\$3.92 billion by 2028 at a com-pound annual growth rate (CAGR) of 4.8% from US\$2.71 billion in 2020. In 2021, Pakistan exported 156,000kgs of fluorite that was worth US\$30,000 million.

The most common use of fluoride is for toothpaste production. Its processing is not anything too difficult. #### Heat, then floods ruin Pakistani farmers' livelihoods

ISLAMABAD: Generations of Rahim Buksh's ancestors have laboured in the rice paddies and wheat fields surrounding Pakistan's hottest city, no strangers to intense summers or monsoon

But this year Jacobabad lurched from record heatwaves in May to an unprecedented deluge of rain in August that drowned

The floods forced tens of thousands of people to flee for makeshift camps and relatives' homes, leaving them doubting the future of farm work despite their deep connection to the land.

"We would move to the cities and take up manual labour work if somebody helped us to

get out of here," said Buksh, whose mud-brick home was flooded, like much of the surrounding farmland.

Even before the destruction, Jacobabad and dozens of nearby villages were crippled by poor infrastructure. Most of the district's

million-plus population are itinerant farm workers, earning a daily wage tending crops for major landowners.

Poverty, debt and the unequal distribution of land have made their livelihoods precarious, but the rise of extreme weather events linked to climate change has deepened the insecurity.

This year's crops were first scorched by temperatures reached 51 that degrees (124 Celsius Fahrenheit) in

only to be drenched by monsoon rains that affected a third of the country - a scale never seen in Pakistan.

"If you are not provided a copy within three days then we will hear the matter again," said the judge. He also shared that his court at times would issue short orders and release a detailed verdict later.

"I expect you will get the certified copy in three days," said the IHC CJ.But Khan's lawyer contended that his client has to contest elections. At this, Justice Athar Minallah said that under the law Imran Khan was only disqualified from the seat he held currently. If he wants to contest again, he can do so, there is no bar on him, he added Zafar then told the court that the media had received the copies of the order and programmes were aired on the issue, adding that ECP did not issue any objections to those programmes. The four-member ECP bench headed by Chief Election Commissioner Sikandar Sultan Raja announced its verdict on Friday at ECP Secretariat in the Toshakhana reference filed against PTI Chairman Imran Khan declaring his National Assembly seat

vacant.

The decision which was made last month by the fivemember ECP bench was unanimous. However, the verdict was announced by a four-member bench today as
the ECP Punjab member Babar Hassan Bharwana
could not attend the commission's proceedings as he
was not feeling well.

According to the verdict, Imran Khan committed
dishonesty and the commission has ordered criminal
proceedings against him under Article 63(1)(P).

The office is directed to initiate legal proceedings and to take follow-up action under Section 190(2) of the Elections Act, 2017. Article 63 (1) (p) of the Constitution states that an individual is, "for the time being, disqualified from being elected or chosen as a

Constitution states that an individual is, "for the time being, disqualified from being elected or chosen as a member of the Majlis-e-Shoora (Parliament) or of a provincial assembly under any law for the time being in force" Prior to the announcement of the verdict, a number of PTI leaders including Shah Mehmood Qureshi, Faisal Javed, Shireen Mazari, Umar Ayub, Fawad Chaudhry, Asad Umar, Shahbaz Gill, and Ijaz Chaudhry were present outside the ECP However, the capital city police barred the political leaders from entering the ECP building and stopped them at the gate. Many tried to climb over the gate to reach the building. The ECP had reserved the verdict in the Toshakhana case on September 19 last. The reference was filed against the PTI chairman by the coalition government, for "not sharing details" of Toshakhana gifts and proceeds from their alleged sale. Established in 1974, the Toshakhana is a department under the administrative control of the Cabinet Division. INP

that is growing increasingly angry at the conduct of its politicians.


"The United Kingdom is a great country but we face a profound eco-nomic crisis," Sunak said in a state-ment declaring his candidacy on Sunday.
