# SC verdict about Reko Diq proves Balochistan Govt's principled stance: Bizenjo

QUETTA: Chief Minister Balochistan, Mir Quddus Bizenjo termed the supreme court's judgment about the Reko Diq project as proof of his government's principled stance. Despite all odds, my government succeeded in government succeeded in protecting the rights of the people of Balochistan, Mr. Bizenjo told reporters at the Chief Minister's Secretariat on Tuesday evening. Other provincial ministers were also present on the occasion.

"I cannot explain, which kinds of troubles we faced in striking a successful deal with the company", he said. This was for the first time in the history of Balochistan that all stakeholders including all political parties out-side and inside the assembly were taken on board prior to the Reko Diq agreement.

#### BGC to invest 8 billion USD in Reko Diq

Chief Balochistan's comments have come a day after the apex court endorsed the government's agreement with the Barrick Gold

Corporation (BGC). The Chief Minister said Reko Diq would bring an investment of more than 8 billion US dollars, which



will open new vistas of development and prosperity in the province and country. He reiterated that the com-pany would provide direct pany would provide direct 8000 jobs to the people of Balochistan and indirectly thousands of jobs would also be created after the functioning of the multi-billion dollar gold and cop-

per project.

"Minerals are the future of Balochistan", he said. The CM said his government was committed to attracting national and for-eign investment in Balochistan to promote the socio-economic conditions of the province.

#### All political parties endorse the government's stance

Balochistan said he met all key political leaders of Balochistan to develop consensus and seek guidance from them with regard to the agreement with BGC about the Reko Diq project. "This was not my personal decision rather all political parties", Mr. Bizenjo stated.

The CM also appreciated the efforts of former prime minister Imran Khan and Shaukat Tareen with regard to the success of the Reko Dig agreement. "This would be an injustice not to men-tion them", he added.

# Opposition opposes Reko Diq bill from **Balochistan Assembly**

QUETTA: Opposition lawmakers opposed the passage of the Reko Diq bill from the Balochistan Assembly. The session of the assembly resumed here with the deputy speaker Balochistan Assembly, Sardar Babar Musakhail in the chair. "This is an attempt to usurp the rights of the people of Balochistan", Muhammad Akbar Mengal, the Balochistan National Party (Mengal) said while speaking on a point of order on Tuesday evening. However, Balochistan Minister Noor Muhammad Dumar, who belongs to the ruling Balochistan Awami Party (BAP) said the house had adopted the resolution in the presence of opposition lawmakers. He termed the Reko Diq agreement a historic agreement, which preserves the rights of the peo-

#### The debate comes three days after the passage of the resolution

The debate in the assembly has come three days after the house adopted a resolution entrusting some taxation powers to the federal government in the Reko Diq project. "Rulers should stop exploiting the resources of Balochistan", Akbar Mengal stated. Although, Chief Minister Balochistan, Mir Quddus Bizenjo claimed to have taken opposition lawmakers on board with regard to the tabling of the resolution in the assembly.

CM Bizenjo claims to have convinced the opposition about the passage of the resolution



The CM said the opposition's misunderstandings about the resolution have been removed and grievances addressed. However, Akbar Mengal claimed that the treasury mem-bers passed the bill in the darkness of night and deceived the people of Balochistan. Balochistan National Party (Awami) lawmaker Balochistan National Party (Awami) lawmaker and provincial minister of Agriculture, Asad Baloch strongly criticized prime minister Shehbaz Sharif and said that the latter was inaugurating motorways in Sindh and giving a cold shoulder to Balochistan. "We also demand a motorway in Balochistan", Mr. Baloch said. Due to a lack of quorum, the chair announced the adjourning of the Balochistan Assembly session.

### Clear evidence of India carrying out terrorist activities in Pakistan: Rana Sanaullah

Interior Minister Rana Sanaullah said on Tuesday that there was "clear evidence" India carrying out terrorist activities in Pakistan, adding that the government has decided to present the matter before the inter-

"We have decided to bring our stance before the world and unveil India's face of terrorism," he said in a press conference in Islamabad, flanked by Punjab Counter Terrorism Department Additional Inspector General Imran Mehmood.

"For decades, Pakistan has been burning in the fire of terrorism. Our mosques, imambar-gahs, important buildings, and gatherings have been targeted.

"Today, the matter that we are putting before you [...] we have evidence of India's involvement in it," Sanaullah said, referring to the Johar Town blast in Lahore last year.

In June 2021, a powerful blast near the residence of Jamaatud Dawa chief Hafiz Saeed in Johar Town had killed three people and injured 24 others, including a police consta-



Malik, 50, and a young passerby died in the explosion that left a four-foot-deep and eight-

foot-wide crater on the road and damaged several houses and shops nearby. Days after the incident, the then information minister Fawad Chaudhry and national security Adviser Dr Moeed Yusuf told a press conference that the mastermind of the attack

was "an Indian citizen and he is associated with [Indian intelligence agency] RAW". Earlier this year, Dawn reported that the Punjab CTD had claimed to have arrested the Johar Town bomb blast from Balochistan. They were identified as Samiul Haq and Uzair Akbar. In the press conference today, IG Mehmood briefed on the investigation of the blast and revealed that the authorities had revealed the culprits.

"Basically, at 9am on June 23, 2021, a bomb blast was reported in Lahore's Johan Town. Three citizens were martyred and 22 were wounded in the blast. To date, no terrorfor the attack," he said. # students at risk in **Balochistan**

The education of 3,86,000 students is at risk in flood-affected areas of Balochistan. Floods and heavy rainfall damaged around 3,000 government-run primary, middle and high schools across the province.

The damage to schools across Balochistan has affected the schooling of 3,86,000 students. This figure is as per the data shared by the Balochistan Secondary Education Department. Although, the independent sources put the number of students and damaged schools higher than what is being quoted by the officials.

The education department admits that still, over 1 million children are out of school in the province, lagging behind other provinces of Pakistan in all key

Reconstruction of schools a major challenge for the government
The recent monsoon has further compounded the problems of students. The number of government-run primary, middle and high schools in Balochistan is over
15,000. The reconstruction of 3,000 damaged schools is a major challenge for the
provincial government, which appears to be least bothered about the state of educa-

So far, the data is only shared at the departmental level. The government has not spoken about the reconstruction of damaged schools and resuming educational activities there. UNICEF has only established 22 temporary learning centers (TLCs) with over 2,000 enrollments. This is simply nothing as compared to the number of stu-

dents deprived of education.

Govt, opposition solely focusing on PSDP

The provincial coalition government and the 'friendly' opposition have solely focused on their schemes in the Public Sector Development Program (PSDP) 2022-They want to get the schemes completed and implemented by hook and crook

and uttered not a single word about the reconstruction of damaged schools.

The reconstruction of schools and ensuring the availability of basic facilities would require billions of rupees. The lives of students should not be put at peril to study in damaged classrooms as anytime the damaged rooms and walls can collapse.

So no risk should be taken in this regard.

The Balochistan government, UNICEF and other non-governmental organizations on patiental and integrational levels working for the proportion of education should

on national and international levels working for the promotion of education should take notice of the situation and ensure the reconstruction of damaged schools. Then, the students should be allowed to keep continue their stalled studies.

we talk in the context of Balochistan, the first question that strikes us that, 'Is there any study ever conducted to find out the Gender Gaps? Did we undertake any post or pre-budget assessment of the annuassessment of the annual budget on different segments of the society, especially women, who form almost 50% (48.76%, to be specific) of our national population? In Balochistan, this ratio this ratio is 47.47%. If our budget is not Gender

Sensitive, almost half the population is left out. In our set up womenempowerment starts and ends with the provi-sion of Sewing Machines, the opening of embroidery centers, or the holding of few cultural shows. It means a gender-based assessment of budgets, incorment of budgets, incor-porating a gender per-spective at all levels of the budgetary process, and restructuring rev-enues and expenditures is required in order to promote gender equali-ty. As mentioned above female population in Balochistan is 47.4% and their needs are completely ignored at

all levels and they are hardly involved in the budgetary process. An analysis of PSDPs since 2013-14 till 2020-21 shows that there was not a single project in the years 2013- 14 1st 2014-15, as if women did not. Exist or they were not worthy of any consideration. Then from 2015-16 to 2019-20, there were one to three projects and the total outlay ranged from 12% to .22%. It shows how much priority that 47,49% of the population gets in the province. Although the world over women is

not categorized as a vulnerable group.

In Balochistan, they are not only vulnerable but also marginalized But the treatment they get in Pakistan, espe-cially in Balochistan, they are not only vulnerable but also marginalized in the real sense of the world. A UN Report on Women said that compared to men, women have 26% fewer chances of employment, and around 75% of the women labor force works in unregulated sector of the economy. Why they are considered vulnerable because

they are solely dependent on male counterparts both at home as well as at the work place. Surprisingly there are no separate Rest Rooms(Washrooms) for ladies in Secretariat and Rooms(Washrooms) for ladies in Secretariat and directorates. For the entire female population, there is only one female park in Smugli Road and they have no recreational facilities whatsoever.

There is a women's Development, mostly manned by male officers and workers, who are supposed to work for the welfare of female workers. They lack the capacity to formulate and implement plans for female uplift. Conditions outside the Conditions outside the capital city are simply deplorable. Economic Development will remain an unrealized dream unless the gov-

## **Drinking Water Quality Status And Its Sources Of Contamination**

Due to intimidating increase in population and rapid-fire industrialization, drinking water quality is being deteriorated day by day in Pakistan. This review sums up the issues of colorful exploration studies conducted for drinking water quality sta-tus of different areas of Pakistan by taking into account the physicochemi-cal parcels of drinking water as well as the presence of colorful pathogenic microorganisms. About 20 of the whole population of Pakistan has access to safe drinking water. The remaining 80 of

population is forced to use unsafe drinking water due to the failure of safe and healthy drinking water sources. The primary source of impurity is sew-erage( fecal) which is con-siderably discharged into drinking water system inventories. Secondary source of pollution is the disposal of poisonous disposal of poisonous chemicals from artificial backwaters, fungicides, and diseases from husbandry sources into the

Anthropogenic conditioning beget waterborne conditions that constitute about 80 of all conditions and are responsible for 33 of deaths. This review highlights the drinking water quality, impurity sources, sanitation situation, and goods of unsafe drinking water on humans. There's immediate need to take defensive measures and treatment technologies to overcome hygienic condition of drinking water inventories in different areas of Pakistan.

Water quality common sewer with the

Drinking water is mainly taken from surface and underground aquifers near rivers and canals. Surface water quality is rapidly declining due to the addi-tion of raw municipal and industrial wastewater as well as agricultural runoff to the water source. When river water flow is at its highly concentrated suspension. Most rivers are one and thin and do not support aquatic species. It is clear that these

waters are contaminated with faeces and need to be treated appropriately to remove the contaminants for human consumption. In Pakistan, four major cities use surface water, these are Islamabad. Karachi Rawalpindi Hyderabad.

The main cause of microbiological contamination is the mixing of the

domestic water supply. In most rural areas of Pakistan, surface water is used for drinking after slow sand filtration, and chlorination is not per-formed at filtration stations. In most rural areas, there is no pre-treatment facility for water purification. All this deficiency is nation and poor water qual-

Sources Contamination: Microbiological

Contaminants; In Pakistan, microbial pollution has been discovered as one of the serious problems in rural as well as urban areas. This is due to the leakage of pipe, pollution from sewage lines intrusion into drinking water supplies, and so

Chemical Contaminants; Chemical pollutants that

come from industries, soil sediments and agricultural runoff, i.e. pesticides and fertilizers, enter water sources. In Pakistan, the use of fertilizers and pesticides is around 5.6 million tons and 70,000 tons respectively according to gross profit (GOP) figures.

These chemicals, usual-

ly insecticides, leach into with irrigation water and rainwater. Between 1988 and 2000, about 107 samples were taken from groundwater, and 31 samples showed clear pesticide contamination above the limits set by the Food and Agriculture Organization of the United Nations (FAO) and WHO. Another significant problem for groundwater in Pakistan is higher salt concentration, which is mainly caused by irrigation activities, salt dissolution in soil, seawater intrusion and chemical

Wastewater from indus-tries and households has high levels of arsenic, becoming a serious prob-lem. In the major cities of Sindh and Punjab, about 16% of people were exposed to more than 50 ppm of arsenic. ith one foot on a banana peel, we are standing at an abyss. PM Shehbaz Sharif and the PML-N face mortal political and economic challenges, and the government has shown little resolve to confront them head-on. It is morbidly satisfying that Shehbaz Sharif and the PML-N — of motorway, flyover, and

For decades, our cities have facilitated private car owners at the expense of pedestrians, cyclists, and transit users. The Shehbaz Sharif model of urban development, albeit with different speeds of execution, pervades other political parties and leaders as well, large-scale gray infrastructure like signal free corridors, flyovers, underpasses, and ring roads with obscene levels of service have els of service have become the norm in cities around the coun-Cities, Islamabad to Turbat, have become sprawling sites of speculatively held vacant plots in

shady housing schemes.

This is our real tragedy. Our current economic crisis is our Frankenstein's own Frankenstein's monster staring right back at us. Consider these examples: Capital Smart City Islamabad is approximately 40 kilometres from Blue Area. DHA City Karachi is over 60kms from Frere Hall. These and other Hall. These and other projects exclusively tar-get car owners: only the most influential five per cent of our urban popu-So what to do when

ple's financial and residential interests move 50kms from the city's economic hubs? Build economic hubs? Build expressways, signal-free corridors, ring roads, Lyari Expressways, and Leh Expressways to coddle them. These projects help the elite bypass the city's congestion, often by taking a longer route. Sometimes flyovers and underpasses address particular points of congestion in the city's road network. As

these projects material-ize, the richest few begin to travel more and more to reach their workplaces, meet friends, or for other everyday tasks. Because there's no public transit and whatever transit exists is class incompatible - people drive, often in their sparkling new SUVs.

By Faizaan Qayyum The same logic has unfortunately extended unfortunately extended to inter-city travel. We have prioritized motor-ways and highways over railways. Our railways network has shrunk from over 8500kms of tracks in 1950s to around 7,800kms today. This has been accompanied by a drastic drop in the railways' share of traffic while the service carried over 86 per cent of all freight traffic in the 1950s, its current share stands at a meager 4-6 per cent. Similarly, Pakistan Railways has gone from the single gone from the single largest carrier of passen-ger traffic in the 1970s to carrying less than 10 per cent of all passen-

gers today. This drastic decline is According to one esti-mate, the state spent three times as much on intercity road infrastructure than it did on rail-ways. The uniformed state's patronage of entities has combined with private car owners' interests to completely overpower socioeconomic efficiencies asso-

ciated with rail travel. All these developments are brazen examples of elite capture. Only around 10 per cent of all urban households own cars, and yet all of our cities have seen massive infrastructural investments that favour

tutional right of assembly ever been put to the test till now. This has now changed. While the federal government wants to curb this right in the public interest, the Punjab government sup-ports it. The fear is that the right to protest in Islamabad may be subjected to prior official permission.

A district administration can easily manage long marches or an assembly of people, but in the case of Islamabad, the highest and all-powerful constitutional bodies like the federal cabinet, Supreme Court, and high court are also involved in allowing or banning the activity.

And instead of getting guidance from the local district administration or traffic police, the citizens of the twin cities of Islamabad Rawalpindi tend to interpret off-screen arguments among contesting powers before sending their children to school

or going to work. In this process, they also try to decode the body language of the personnel law-enforcement agencies to see how they are going to deal with aggressive protesters.

In Pakistan, the right to assembly is also interpreted as the right to protest. There are no conditions on the freedom of assembly except that it has to be within the legal parameters and

should be undertaken without violating any laws. However, different court rulings have held that the right to protest is not absolute, and peaceful protesters cannot infringe on the fundamental rights of other citizens. Public functionaries thus have to ensure that the constitutionally guaranteed rights of every citizen are protected.

Maintaining public order is a crucial respon-sibility of the state and its functionaries, but preventing a protest from turning violent remains a challenge for them. Limitations on the right to assembly are enforced by a duty magistrate who can employ remedial measures if s/he considers that the protest may pose danger to human life, health, or safety, disturb public tranquillity, or turn violent. As per the law, only a government functionary can initiate legal proceedings against vio-

This was in addition to the more than Rs200 million already allocated in the annual budget for similar purposes. Among the 33 ministries and divisions of the federal government, the interior division is the largest administrative unit. It has 237,821 civil armed forces (CAF), which comes out to be 42 per cent of the actual working strength of 565,082. Rumours have it that

It bles, seems the protesters are set to fight law-enforcement personnel.To deal with any untoward situations, the government has deployed at least 13,086 personnel – 4,199 Islamabad police officials, 1,022 Sindh police officers, 4,265 FC personnel, and 3,600 Rangers - in different areas of the capital. The law-enforcement agencies have been provided with 567 teargas guns with 50,050 teargas shells, 500 12-bore guns

with 37,300 rounds, 2,430 masks, 335 vehi-

cles, 17 paper ball guns, 11,000 paper balls, 10,500 spray paint, and

26 megaphones to counter any violation made by troublemakers.

A big portion of this law-and-order maintenance is running cost. For example, food charges for 15,000 officials of the capital and other district police for five days is over 41 million. The per-day rent cost of one container is Rs25,000. There are reportedly 380 containers around the city. The more the sit-in is delayed, the more costly it will become.

This taxpayers' money can be spared if protests are peaceful, but disruption of public life does cost a lot. It is tough to quantify the total loss as, in addition to government functionaries and lawmakers, the judges' time in adjudicating protest-related matters also cost the exchequer.

According to one estimate, during 2012-2018, the total economic loss to the country because of protests in Islamabad was Rs1.5 billion. In 2018, while replying to Rana Sanaullah Khan (the incumbent interior minister), the then interior minister, Brig (r) Ijaz Shah, told the National Assembly that over the last seven years, the country's economy suffered an estimated loss of over Rs1.1 billion due to sit-ins and lockdowns held in Islamabad. In order to become a globally competitive economy, Pakistan must introduce market-orientated reforms. There is so much talk about Pakistan's weak export performance. Upon examination, it is clear that the export market is subpar due to deep structural issues. Pakistan's exports have continually fallen behind its South Asian competitors since the early 1990s. Since 1990, Bangladesh's exports have increased 6.2 times compared to Pakistan's, measured in terms of

To strengthen the export market, the current and future leaderships have to make unpopular decisions and stick to them. Over the years, governments have continued to dole out large export subsidies without a shred of evidence that these subsidies have helped boost exports. Going forward, governments have no choice but to bite the bullet and say no to special interests. For

example, instituting a land tax and rationalizing agriculture to create efficient farming choices can be done. However, sticking to the policy and carrying through requires courage from the government, and support from the public. To achieve long-term economic stability, Pakistan must have the will to put the interests of the people ahead of the privileged few. That means taking bold decisions, like removing land subsides and charging for excessive water

We also know that the economy cannot be restructured if political instability continues. Now more than ever, principles need to be put above petty political feuds. Pakistan must take a leaf out of Bangladesh's book, as it shows that you don't need complete, but just semi political stability and continuity to achieve economic growth. For that to happen, Pakistan needs to get past the first hurdle. Political tumult and confrontation has done nothing but create hardship and upset. The people have had enough.

Pakistan needs to prepare itself for a hard grind. With the steep rise in inflation, there is bound to be more social unrest around the corner. It is highly doubtful that the politicians will tone down their rhetoric and work together.

## China shares green power experience with Pakistan

Pakistan's energy import bill exorbitantly touched \$27 billion, prime minister Shehbaz Sharif underlined the need for exploiting indigenous resources including hydel, solar, air and coal to produce

and wind resources," said Wang Haowei from Shanghai Electric, who is the business manager of Zhang Jiakou Green Power Project.

Shanghai Electric Group has a global pres-

efficient clean energy industries. Its Zhang Jiakou Green Power Project is a part of the multi-energy integration and optimization demonstration project. It covers achieved 100% green power supply for all venues of the Beijing

Winter Olympics.

"The installed capacity of the project is 150 MW wind power, 30 MW photovoltaic power and 10 MW energy storage." Wang Haowei told us that the project is characterized by the complementarity of various new energy generation systems.

"The feature of wind power generation sys-tems is that their output at night is more than that during the day, while photovoltaic power generation systems have output during the day only. The energy storage system can adjust the volatility in the power generation process of the other two systems

"Compared with tra-ditional thermal power generation, the project can save 1.48 million tons of standard coal and reduce carbon dioxide emissions by 3.69 million tons per year, also actively cooperat-ing with other Belt and Road countries in power generation system con-struction, bringing its advanced technology and equipment to more countries. Dubai 700 CSP and 250 MW PV project in Dubai can be

a good example.
"This is the largest single-site concentrated single-site concentrated solar power plant in the world, the CSP part is 700 MW in total, consisting of 100 MW CT unit and three 200 MW PT units; Photovoltaic 250 MW, which maximizes the site application," introduced Zhao Hui project manager of Hui, project manager of Dubai 700 CSP and 250 MW PV project.

Concentrated power generation works by using mirrors and heat exchangers to collect the Sun's thermal energy and provide steam, and then gener-ate power from steam with traditional turbogenerators.

"This power genera-tion method not only can be as clean and renewable as photo-voltaic power genera-tion, but also has the safety and stability of thermal power genera-Zhao added.INP

Policies are changed to appease capitalists who donate heavily to political parties, SROs are released frequently, competition for investors is eliminated and packages are announced to increase their profits, the President PEW added. Dr. Murtaza Mughal

said that the promotion of the elite makes them richer but people are deprived of quality and cheap goods. In addition, every new

government announces unnecessary subsidies to please the voters, which burdens the exchequer and now the state of the economy has become so precarious that ques-

tions are being asked about its survival. Decades of policies revolving around the elite have bled the coun-try white and economic managers are running from pillar to post to avoid a default.

For the sake of its vote bank, the new gov-ernment does not want to collect taxes from the businessmen, nor does it want to close the shops in the evening which can

save billions of dollars. At present, the rulers are not informing the people about the real state of the economy and assurances are being extended.

Tough decisions are not being taken out of fear of annoyance of voters. If tough decisions are taken, people will be angry, but if not, there will be a default, he warned INP

#### **SECP** registers seven new Private Funds in 2022

ISLAMABAD: The Securities and Exchange Commission of Pakistan (SECP) has registered seven (7) new private funds under the Private Funds Regulations during the calendar year 2022.

Given that the Private Funds industry for past many years had only five funds, the registrations of two Venture Capital (VC) funds, four Private Equity and Venture Capital (PE&VC) funds and the country's first alternafunds and the country's first alterna-tive fund is a significant development. Incentivized by the consistent reform measures, a sharp growth has been witnessed during the past three years in the number of PFMCs from four to ten, leading to an increase in the num-ber of players in the SECP regulated PF industry. The new funds, worth approximate-ly Rs. 13.6 billion are expected to be

ly Rs. 13.6 billion are expected to be launched within the financial year ending June 30, 2023. Following the launch of these funds, the cumulative asset size of PF sector is expected to increase to PKR25.8 billion, from PKR12.287 billion as on September 30, 2022, indicating a growth of 110 percent.

percent.
The SECP conducted a 'Diagnostic Review of Pakistan's Private Funds Industry' and recommended measures to revitalize the sector. The Federal Board of Revenue (FBR) on the rec-ommendation of SECP exempted the income of PE&VC funds from tax. In addition, the SBP has issued a clarification regarding its Prudential Regulations

Corporate/Commercial Banking for explicitly allowing banks to partici-pate in PF units.

The SECP has also allowed insur-

ance unit linked funds and equity subfunds of pension funds to invest up to 5% of net assets in PF units. The

implementation of several key recom-mendations of diagnostic study has led to record growth in new PF registra-tions and is expected to direct private capital to the sector.

KARACHI: The President of United Business Group (UBG), the strongest representative organization of Pakistan's business community, Zubair Tufail while commenting on the current economic situation said that the country's economic, financial and financial crisis has scared every-

one in the country.

He said that the manufacturing sector is facing difficulties in continuing the production process in the extreme-ly unfavorable conditions and the current weakest economic scenario, the decrease in foreign exchange reserves is making it more difficult for Pakistan to pay its foreign debts. It is becoming more difficult to get dollars for imports, due to the impact of industriprocesses, exports have also suffered. Talking to UBG Karachi Region officials, Zubair Tufail said that the major source of dollar inflow from foreign countries is overseas Pakistanis who are strengthening the treasury by sending remittances every month but month by month. Decrease in remittances what is worrying is that in October 2022, 2 billion 2160 million dollars were sent by Pakistanis from foreign countries, which was 2210 million dollars less than in September 2022. There has also been

a decrease in remittances The UBG President said that all the governments in Pakistan have burdened the country with loans from international financial institutions and friendly countries, on the country's ability to pay huge foreign debts. The concern expressed to some extent is correct and the ever-increasing concerns are creating frustration among exporters, importers. INP
