QUETTA VOICE Editor Asim Khan Unsafe Gas Cylinders in Balochistan

Gas cylinder blasts have claimed scores of precious human lives in Balochistan. A recent gas cylinder blast in Balochistan's Kohlu injured 33 people including 31 children. Six children critically injured as a result of the blast have succumbed to injuries in the burn unit of Punjab's Multan hospital. Seven minors are still battling for their lives at the burn ward.

Unsafe gas cylinders in Balochistan

All the victims had suffered burn wounds when the gas cylinder exploded with a big bang in the Bohri area of Kohlu district. Police said children had gathered around a potato chips seller when the cylinder went off during a wedding party. A similar gas cylinder blast claimed 6 precious human lives in Balochistan's Pishin district.

Gas cylinder blasts have almost become the order of the day in Balochistan. There seems to be no mechanism to check the quality of gas cylinders. The sale of sub-standard Liquefied Petroleum Gas (LPG) cylinders is on the rise in the market. LPG sellers are busy illegally filling the gas cylinders to mint money right under the nose of the authorities.

LPG decanting from one cylinder to another using an electric motor is prohibited by law but the practice is continuing due to the absence of strict monitoring by the authorities concerned. Since the residents face low gas pressure issues, using LPG as an alternate source is the only option for them. Not only domestic cylinders are being filled, but LPG is also being filled in vehicles through electric motors.

People smoking while decanting the LPG

It can be observed that shopkeepers decant LPG without taking any safe-ty measures. People, customers, and even shopkeepers can be seen smoking while decanting the LPG. The government is yet to take notice of such inci-dents. The officials hard take notice. Regarding the Kohlu tragedy, the incident happened on November 8 and the police registered the FIR against the accused on November 14. This reflects the interest of the concerned quar-

In rural Balochistan, such incidents are rampant. Although, very few incidents are being reported. The Balochistan government needs to take notice of such incidents and form a committee comprising experts to evolve a proper mechanism in this regard to avoid future human losses. Rulers need to be framed and the LPG sellers must be strictly monitored to ensure implementation of the said mechanism.

Lessons in school reforms

akistan has struggled to maintain any kind of stan-dard at both government and private schools across the coun-try. While private schools often claim to offer the best education and learn-ing in English to their students, they are not always successful

The kind of education that many children receive is based on rote learning and cramming -similar to how they would learn at most gov-ernment schools. The only difference is that parents pay exorbitant fees for their children's education at private schools. Only high-tier elite schools – which charge high fees and are accessible to only a tiny minority - can claim to offer education which international standards

According to the available surveys, a majority of Grade-5 children at both government and private schools are unable to write a complete sentence in either English or Urdu The conflict of the languages adds to the prob-lem. At English-medium schools, children are taught in English and barely understand the content they have been taught. When the same content is provided to them in Urdu, their eyes light up. Children who have never been exposed to English at their homes and have received no spe-cialized English tuitions

at their schools begin to understand the concepts.

It is unclear why the country has not chosen to follow models from other countries where children are first taught in their mother tongue so they can understand the content, and then in later grades, they are taught English as a skill they will need for employment

opportunities.
In our country, the situation is dismal. In Punjab, the education authorities have neglected Punjab; this has added to the problem. Punjab is the only province which does not offer primary-level education in the native tongue of most children, often leaving them blank in the class, unable to comprehend what they are learning. The only option for them is to cram what is put before them to

pass the exam.
Pakistan does not need just major education reforms. The Single reforms. The Single National Curriculum (SNC) offered by the PTI government solved no problems and, in some way, added more to them, emphasizing cramming and taking away from a child's intellectual ability to develop skills. This is a deeply rooted problem and should be solved if the country is to progress and grow in any direction.

So, how do we go about it? One method would be to study the example of Vietnam, a desperately poor country in the 1990s, whose per

capita income has now grown massively; the Vietnamese government thinks it can grow further if education is massively reformed through the reteaching of teachers and other methods. Such strategies help education become child-centred, based on the capacity of children to learn and then acquire places in univer-sities and gain jobs. In Vietnam, the empha-

sis is not only on STEM (science, technology, engineering and math) subjects but also on development of other skills. These reforms have been massive, and ir some schools, classes were shut down for some days to allow teachers to be trained in the new method required for

teaching.
The same happened in Japan, and since the 1990s, the Japanese committee responsible for education has recognized that cram learning is not helpful. Japan adopted and introduced an approach centred child-based learning and the individual ability of children at schools one by one This initially resulted in a steep fall in education standards as measured through global academic benchmarks. But Japan has since then caught up and retained its policy of training children not to cram, not to depend entirely on teachers, and to further their skills through their own initiatives and learn through these rules.

Balochistan unending wheat crisis

Pakistan is an agricultural country, having 70 % of the population directly depend-ent on agriculture, while the other 16 % is indirectly linked to it. Its people have always been buffeted, after every 4-5 years interval, with the crisis of staple food, in particular the wheat grain. Other than Punjab, no other province is self-sufficient in wheat production, thus gener-ating total and everlasting dependence on a single

Punjab has traditionally been the fruit basket of the sub-continent

Punjab has traditionally been the major part of the food basket of the sub-continent due to it being the land of rivers. After the partition of India and the consequent division of Punjab, the staple food dependence of western Pakistan continued to be on

The frequent crises, the poor man is subjected to, are despite the vast arrangements in place in the form of public departments sector Agriculture and Food.

Agriculture Department, with heavy resources at its disposal, has fallen short to contribute in mitigating the crisis by giving incentives to farmers to grow wheat. The production of wheat in Balochistan is nearly 0.8m tons, meeting nearly 50% of its requirements. Due to the sparse population, the Agriculture department's sources are sufficient enough to add a million tons of wheat grain.

The Food department, functioning as procuring and stock-maintaining agency, was brought into existence in British times when the staple food crop was not enough to meet the requirements of the population

Earlier, ration cards were being issued as per the number of family members

Initially, wheat and sugar were stored in department stores. In addition to storage, a rationing arrangement was put in place. Under rationing, the ration cards were issued according to the number of family members and through that ration, dealers would issue the allocated quota. It continued until the late seventies when bumper crops were produced with the introduction of machinery replacing the age-old farming means.

The Food department at the provincial level continued

with seasonal procurements of wheat under state trading. In other words, the public exchequer was allowed to be used by the Food department to indulge in trade and to store a strategic reserve of 3 months to be utilized in any eventuality. When the blight of stagnancy overtook the public institutions, the state trading couldn't evade it, rather it suffered the most. The wheat trade under the aegis of the Food department turned into a lucrative source of income for a minuscule coterie consisting of a few individuals. To be more specific, they were those controlling the department at the top, using as tools, the public officials who stand in low pay-scale hierarchy thus get-ting petty salaries but taking care of hundreds of millions of rupees stock and the wheat grinding facilities owners.

The department is tar-nished to an extent that procurement is considered as a dark motive

The state trading got characterized by consistent losses, multiple subsidies (at purchase and selling stages), influential interest groups (again a few), convoluted procurement and sale, stock spoilage, and a series of unending inquiries sans conclusion. The department is tarnished to the extent that procurement(its sole purpose of existence) case initiation is considered as the dark motive of the head office of the department. It goes to the credit of influential parliamentarians of the wheat-propolitical clout to make it happen, irrespective of the opinion of the department officials, as they stand irrelevant. At the next stage, the irrelevant officials have no say to select poor farmers for whom the subsidy from the public exchequer is made.

The first right over the subsidy turns out to be of those who made the procurement take place. As all public institutions are to serve the already served class, the poor farmer toil as usual without

knowing about the subsidy in his name. It not only deprives the poor farmer of his due right Los, but he also loses interest to cultivate wheat for his co-citizens. One twist in the system lead to another; the weak officials with no option but to pick what awaits them and pile stock in department stores, main-tained with public exchequer, ending up into unsaleable stock. Here unending saga of woes begins: either to scale down the purchase price to make it compatible with a marker or be ready for a daredevil functionary who will sell the stock and throw the job along with trickling wages to the wind. Thus, a purpose for the processes of 'put up', is engendered (the buzzword of every public

It takes three months to place funds to purchase wheat

The procurement wheat got so maligned that each case of procurement, when initiated by the department, took more than three months to place the fund at the disposal of the department for the purchase of the stock. The hesitation at different stages, causing the delay, is not enough to prevent it, only the process-es are put off, causing embarrassment only for battered department staff.

Inquiries against the staff and high officials galore but only to punish the individuals against whom the allegations are leveled. The causes of misman-

agement. engendering heavy embezzlements, go by unattended. The element of punishment is predomi-nant to the extent that in one of the inquiries probing the causes of delay of procurement, the inquiry officer sought the help of the Food Account Manual, which deals with accounts of the stock, that was not

there. The manual which dealt with the post-procurement was used to track the travel and stay of file as if Food Account Manual also worked as GPS. It is the only written document dealing with stock and is quoted to whoever wants to make a display of his make a display of his knowledge about the food department. This whole edifice is cre-

ated to keep a strategic reserve to meet emergency requirements in case of natural calamity or war, stabilize the staple food market and fulfill the food requirements of citizens. Unfortunately, none of the ments above needs are met by the stock procured by the food department, involving precious scarce resources and elaborate arrangements in the form of a public depart-ment with millions of running expenditures.

Each year, a target of 0.1m ton is set for procurement from all over the province but it is uniformly made from the Naseerabad division and vicinity. Never has the procurement target been achieved except for very few procurements. The province requirement is nearly 1.6 million tons, while the targeted procurement, even if made, gets to 6.25%. An average of 2 to 3% is stored and that too when the stock is available to be procured. The quoted quantum of stock meets none of the above-stated purposes of the raison d'etre of the food department. emergency ness became evident when in Feb 2019 the war-like situation developed with India in the aftermath of airstrikes in Balakot. In the civil administration meeting called for the preparation for the eventuality of war, the Balochistan Food department reported nil

An anatomy of paralysis

Pakistan's politics has assumed the form of a movement circular keeps coming back to the starting point after exhausting all pos-sible forms of abuse and invective. He reflects the general perception that has developed in the last few months with Pakistan suffering a sequence of setbacks and abject humiliation, both in the domestic and international arenas. Worse still, there does

not appear to be an easy way out of the quagmire it appears to continue sinking into. The question that, at times, haunts is whether there is anyone really interested in helping the country out some effective

remedies? Politics has been reduced to a competition for fabricating ever more

convincing lies to cloud the reality. The economy is sinking with inflation having made it impossible for an average citizen to survive. The state assets are being leased out for paltry relief. Everything is being sold, most deplorably human conscience.

By many objective calculations, we have already suffered a technical default. The institutions have collapsed Terror is raising its mon-strous head. The justice system has plunged into deep slumber. The ECP is practising the art of how to keep postponing elections and how not to respond to genuine queries and questions Crime and corruption have penetrated society The morality fabric lies in tatters. It is a perpetual and brutal battle for survival which constantly trespasses the boundary that separates the right from wrong. The two extremes have coalesced to become the prognosis for surviving a state of hunger and deprivation. But nobody seems to care As T S. Eliot wrote: "The dripping blood our only drink/ The bloody flesh our only food/ In spite of which we like to think/ That we are sound, subcoalesced to become the That we are sound, sub-stantial flesh and blood"

Even more aptly, the situation is like what is portrayed in Mirza Ghalib: "The cities are Ghalib: "The cities are being sold. The state is being bartered. Every asset is up for grabs. Who are these rulers have turned the

country into a retail out-

There are others like me who see hope depleting with every passing day, but don't want to surrender before the descending dark. In an environment of rampag-

ing loot and plunder, the painful struggle to maintain a semblance of sanity and keep your optimism alive is an agonising struggle. There are some who

keep coming up with suggestions to move for-Despite some credible proposals, they seem to be at a loss regarding where to begin from. Who takes the initiative and what would be its form and substance? Who throws in a spark to spread the glow and how do we help this catch on and transform the beliefs and attitudes of a whole nation? Most importantly, is there a way to reform those who have the reins of power in their hands and who are primarily responsible for the current state of penury and humiliation? If reform is not an option, what is the best way to induct a leader-ship that is equipped with the ability to pursue a rational thought rational process and an inclusive approach?

These and more disturbing questions come to mind which have no ready answers. But the country cannot be allowed to continue rotting. It should become functional. It should be lifted to health. It should break the chains of captivity that it is currently shackled in. It should be

free to breathe afresh, casting a ray of genuine hope for its impoverished millions who have lived waiting for better days, only to be plunged deeper into despondency. They should be sal-

vaged.
There are proposals for forging a grand compromise among the stakeholders. It may have some merit, but the country is tottering on the brink simply because of the doings of the very same corrupt elite which continues to have relevance in managing the affairs of the state. If one were to sit across the table for a dialogue with these forces, you can at best have a compromise that would be embedded with controversial policies they have been the authors of during their tenures in power, and they would not agree to reverse what has brought them boundless boun-ties. Will there be any merit in pursuing such a

patently self-inflicting exercise? Let me stress that such a compromise will be untenable because a compromise with corruption will breed more corruption, with crime more crime and with thuggery more thuggery. On the other hand, a struggle to cleanse both system and society of the ailments they have contracted over time can be

daunting Despite counter views, believe that, in the history of nations, there comes a time when, for the sake of the state and its people, it becomes

It does not brook a compromise with those who have pushed it to the verge and who will not agree to cede their chances of squeezing the state coffers further. Unending delays in the process of hiring and promoting faculty members take six to eight years to complete while other universities in Sindh take between six months and a year to do the same.

Underfunding, lack of accountability and disregard of standards allow bureaucratic delays, frustrating KU faculty that now stands at the brink of disorder. Faculty with over 25 years of service are retiring as assistant professors.

Attempts were made to reform governance the and Universities Amendment 2018 simplified the process of recruitment

University continues without policy reforms. Over 400 faculty members applied for the next cadre in 2019, scores have retired and hundreds will superannuate in next five years but are denied the right to present their case to the Selection Board. Recently Dr Zafar Igbal of Environmental Sciences retired after 25 years of service as assistant professor despite a court order to hold his Board. Similarly, Dr Ameer Ahsan of Pharmacy is to retire in October after serving Baqai, Ziauddin and lastly Karachi University while waiting for a Board

Universities only need to follow the University Act that requires three experts with eight board members to select a suitable candidate. Instead University Karachi allows deans, chairpersons, foreign expert reports and secretary boards and universities to further the red-tape in the process.

The University of Karachi needs an overhaul of the existing bureaucratic mindset and to get rid of the assumption that redtape is a substitute for tandards Discrimination against varsities and within a varsity must end by

Country importing wheat worth \$2 billion annually: Tariq Cheema

ISLAMABAD: Federal Minister for National Food Security and Research Tariq Bashir Cheema on Friday said that now Pakistan is importing wheat worth \$2 billion annually, at one time, Pakistan used to export wheat. Addressing a press conference here, he said that this time "we have to import 2.6 million tons of wheat from Russia, out of which we have received 1.3 million tons. The minister said that after the decision of the review committee, the government has decided to import 2.6 million tons of wheat this year.

He said that the government had stored 1.8 tons of wheat in the Strategic Reserve last year, which will contain 1.5 million this year.

The minister said that there is no shortene of wheat/flower wheat in the strategic Reserve last year, which will contain 1.5 million this year.

The minister said that there is no shortage of wheat/flour anywhere in the country, "we have wheat in abundance and the provinces have also been asked to tell how much wheat they want."

He said that provinces including Punjab are not releasing wheat; they are getting wheat as per requirement.

Tariq Cheema said that the shortage of wheat in the country and noise about prices is unnecessary and the government is ready to face all kinds of challenges.

He said that after the 18th amendment, agricultural commodities including wheat are the issue of provincial

It was further observed that the matter had already consumed sufficient time in the disposal due to the accused's miscellaneous applications and was tan-tamount to starting a new round of litigation which prima facie was against the spirit and scheme of the Act 2010.

The president observed that the complainant who had filed a case of sexual harassment under section 8 of the Protection Against Harassment of Women at the Workplace Act 2010 before the Ombudsnerson on

the Ombudsperson on 27,05,2019 had yet not been adjudicated. The accused had filed a representation before the President against the order of 23.09.2021 for seeking permis-sion to reexamine the com-plainant again by a fresh counsel which was rejected.

Dr Alvi in his order observed that the complaint was filed under the Harassment of Women at the Workplace Act 2010 before the Ombudsman on 27.05.2019. The accused had earlier filed a representation before the president against interlocutory order dated 23.09.2021 for seeking permission for the cross-examination of the complainant which was rejected on 26.01.2022.INP
