Massive electricity breakdown across Pakistan

ISLAMABAD, LAHORE, KARACHI, QUETTA: A massive electricity breakdown hit the country Monday morning disrupting life in all major cities including Islamabad, Karachi, Lahore, Peshawar and Quetta.

Tarbela and Mangla dams were tripped,Sources

Sources said transmission lines of Tarbela and Mangla dams were tripped and all power plants in Guddu, Jamshoro, Muzaffargarh, Haveli Bahadur Shah and Balloki shut down. The NPC fuse was also switched off to save the system.

The power supply went off

The power supply went off suddenly at 7:32 am with IESCO, LESCO, MEPCO, SEPCO, QESCO and K-Electric were the most affected. A number of cities in Sindh, Klyber Pakhtunkhwa Khyber Pakhtunkhwa, Balochistan and Punjab were without power supply.

22 districts of Balochistan were without electricity

As many as 22 districts of Balochistan were without electricity and supply was suspended to 117 grid stations of IESCO.

According to QESCO officials, both electricity power transmission lines coming from Guddu to Quetta have been tripped impacting 22 districts including Quetta, Khuzdar, Sibbi and Dera Murad Jamali.

Karachi, the economic hub of the country, also knocked out of the grid because of the

In a couple of tweets, the Ministry of Power said the sys-tem frequency of the national grid went down at 7.34 this morning, causing a widespread breakdown in the power sys-tem. System maintenance work is progressing rapidly." In another post, the ministry said the restoration of power supply from Warsak to grid stations has been started and in the last one hour limited number of grids of Islamabad Supply Company and Peshawar Supply Company have been restored

Country has faced such power breakdowns several times

The country has faced such power breakdowns several times in the past and the recent one showed that the National

that the National Transmission and Despatch Company (NTDC) had failed to put in place permanent remedial measures to overcome such incidents.

The National Electric Regulatory recently imposed a fine of Rs20 million on the NTDC because of breakdowns and

collapsing of its towers.

A similar kind of power breakdown had plunged the whole of Pakistan into darkness on October 13, 2022 when a disruption occurred in two 500kV transmission lines in Karachi.

Before that a major power blackout was occurred on January 9, 2021 which had plunged much of Pakistan into darkness.

2015 an alleged militant attack

In 2015 an alleged militant attack on a key power supply line plunged around 80% of the country into darkness for more than nine hours.

In October of last year, Karachi, Hyderabad, Sukkur, Quetta, Multan, and Faisalabad were hit by a power outage.

Nearly 8,000 megawatts of power went offline,power minister

At that time, the power minister said that nearly 8,000 megawatts of power went offline.

Karachi ATC acquits Rao Anwar, others in Naqeebullah murder case

An anti-terrorism court in Karachi on Monday acquitted former Malir SSP Rao Anwar and 17 others in the Naqeebullah Mehsud murder case.

The brief verdict was announced by ATC XVI judge at the Karachi Central Prison, in which the court said that the prosecution had failed to submit sufficient evidence

against Anwar and other accused persons.

In the detailed verdict released later, a copy of which is available with Dawn.com, the judge said: "I am of the considered view that the prosecution since has failed to bring home guilt of the accused beyond any reasonable doubt and for giving benefit of doubt to an accused it is not necessary that there should be many circumstances creating doubt. One single circumstance leading towards the real doubt is sufficient to acquit the accused. The judge extended the benefit of doubt



The court took five years to conclude the trial of the murder, which had triggered widespread condemnation and debates on

social media about fake encounters in Karachi, particularly by Rao Anwar. The killing of Mehsud, an aspiring model from South Waziristan residing in Karachi, stormed social media with public outcry and sparked countrywide protests by civil society against the state's failure to arrest the former SSP and his team.

Anwar, along with his around two dozen subordinates, were charged with the killing of Naqeeb and three others after allegedly dubbing them militants linked to the "Islamic State and Taliban" in a "fake encounter" on Jan 13, 2018.

In March 2019, the court had indicted Anwar and his 17 subordinates for the

to the accused and acquitted them in the killing four men on the outskirts of

In November last year, the former SSP had recorded his statement, alleging that he had been framed in the case due to a "departmental rivalry", but had failed to name any officer in the police department. During the trial, the court recorded the testimonies of 51 witnesses — including the medico-legal, forensic and ballistics

experts, nine private witnesses and police officials produced by the prosecution.

During today's hearing, the ATC judge noted the prosecution had failed to prove that the victims were kidnapped and murdered in a fake encounter by Rao Anwar and his 14 subordinate officials.

45 PTI lawmakers withdraw resignations from National Assembly

Forty-five PTI lawmakers on Monday collectively withdrew their resignations from the National Assembly on orders of party chairman and former prime minister Imran Khan.

PTI leader Asad Umar, while announcing the devel-

opment on Twitter, said that the lawmakers have sent emails in this regard to Speaker Raja Pervaiz Ashraf.

The decision, he added, was taken after the speaker refused to accept all the resignations together. "The next step will be the nomination of the opposition leader," Umar tweeted.

The lawmakers who have decided to withdraw their resignations include Muhammad Riaz Khan, Muhammad Yaqoob Sheikh, Shaheen Niaz, Nasarullah Dareshar, Zulfiqar Ali Khan, Nafeesa Inayat Khan, Malik Anwar, Saleh Mohammad, Jai Parkash, Tahir Sadiq, Niaz Ahmed, Raza Nasarullah, Javed Iqbal, Munaza Hasan, Lal Chand Malhi, Sajida Zulfiqar, Sardar Muhammad Khan, Uzma Riaz, Tashfeen Safadar, Jawad Hussain and Nausheen Hamid.

Meanwhile, PTI leader Fawad Chaudhry said that the decision was taken so that the party could take back the posts of the leader of the opposition and parliamen-

tary party leader.

He added that the aim of the move was to get rid of

State Bank of Pakistan (SBP) Governor Jameel Ahmad announced on that Monetary Policy Committee (MPC) had decided to increase the interest rate by one per cent to 17pc. He made the

announcement in a press conference following the MPC's meeting. The MPC's meeting. The increase was largely in line with market expecta-

Separately, a press release issued by the cen-tral bank stated, "The committee noted that inflationary pressures are persisting and continue to be broad-based. If these



remain unchecked, they could feed into higher inflation expectations over a longer-than-anticipated period. The MPC stressed that it is critical to anchor inflation expec-tations and achieve the objective of price stabili-ty to support sustainable growth in the future" The MPC noted three major economic develop-ments since its last meeting in November - inflation continued to remain elevated, with core inflation showing an upward trend over the last 10 months; near-term chal-

lenges for the external sector have increased despite the policydespite the policy-induced contraction in the current account deficit and there has been a continuous drawdown

in foreign exchange reserves; and global eco-nomic and financial conditions broadly remain uncertain in the near-toshort term, leading to mixed implications for Pakistan's economy.

"We will stage a protest in Lahore tomorrow, then Rawalpindi the next y," he said in a video address, adding that demonstrations would also be The announcement comes a day after the Election Commission of Pakistan (ECP) appointed Naqvi, a senior journalist and owner of some private TV channels, the caretaker chief minister for a 90-day interim period.

The PTI and its key ally PML-Q had vehemently rejected the appointment and unanimously stated that they would knock on the doors of the court and take to the streets against the electoral watchdog's decision.

During today's address, Imran urged the nation to come out onto the streets and prove that they "are not cattle. "We can't accept a person who is following an agenda and has conspired against me in the past."

Imran claimed that during his time in power, he received reports from the Intelligence Bureau regarding Naqvi's attempts to topple his govern-



ment. "Mohsin Naqvi was the most mentioned player in the regime change

He further said that former president Asif Ali Zardari "considered Naqvi

a son" "You can now imagine what kind of a person he (Naqvi) is that Zardari — known for corruption worldwide — thinks of him as a son." He further said, "In 2018, Naqvi returned Rs3.5 million to the National Accountability Bureau and accepted that he had stolen money." Imran added that Naqvi did not possess morals or a non-partisan character. He predicted that Naqvi would appoint police officials and bureaucrats who opposed the PTI and would attempt to back the party into a correct.

"They are scared of PTI's popularity because we can't be defeated in elections," Imran said. He alleged that Naqvi would not allow provincial elections to take place until the electoral staff was replaced so that the for-

mer opposition's win was guaranteed.

Imran said that the aim of the caretaker government was to be a neutral umpire, adding that the nominees provided by the PTI and the PML-Q were "credible and honest". Web Desk

Giving e-bikes a boost By Syed Akhtar Ali

The government has announced a financing package to promote the sale of e-bikes. These environmentally friendly bikes have the potential to contribute towards achieving environmental objectives, industrial growth and reduction of petrol imports and con-

sumption. E-bike manufacturing is a volume business, and the Pakistan market has the required potential volume. There are 26 million petrol bikes on the road, and around two million bikes are sold every year. Also, it is relatively cheap to own and operate an e-bike than a conven-tional motorcycle. While the upfront purchase cost is higher than that of conventional motorcycles – at least 30-50 per cent, the fuel cost is lower.

In this regard, an ffordable financing ffordable scheme with some inter-est rate subsidy may be beneficial. It is also a good omen that there is continuity of policy in this respect, irrespective

of political changes. E-bikes have a large market share in the developing and poor countries of Africa, South America and Asia-Pacific, It and Asia-Pacific. It appears that the EV car market is small and possi-bly not feasible either for imports or for progressive manufacturing. The story of progressive manufac-turing of automobiles is

not a successful one. Small volumes have been major constraint in building a viable automo-tive industry.

There has been some success in small cars where the price and volume factors are domi-nant. There have been quite a few successes in the area of agricultural tractors, which are being manufactured and even exported. The price and volume factors are visible in this case also although there is an added factor of the peculiarity of the trac-tor market. Cheap credit financing has also pro-moted the tractor market and its local manufacturing. The tractor industry has also benefitted from a lack of dominance and oligopolistic market, something that has been seen in the case of cars.

The import promoting policies of the last twothree decades under the WTO regime and the IMF-World Bank ideology and the entry of cheap-er Chinese goods has not only slowed down local manufacturing initiatives but also damaged the timely emergence and strengthening of the industrial base. The result and consequence is obvious in the prevailing ecocircumstances focusing around current account deficit - imports of \$80 billion vs exports of \$36 billion. High ener-gy imports are one of the leading causes of this problem.

EV expansion may help alleviate these prob-lems to some degree. EV initiatives ought to be associated with the local-ization of energy sources as well. The fast-track solar PV programme may help achieve some targets help achieve some targets to a great extent. Progress in solar PV has been slow in the last few years partly due to the over-capacity issue, which is a common problem in electricity generation due to the lumpy nature of supplies involving 1000-1300MW capacity power plants in the fossil fuel sector. Ebikes have an especially attractive aspect, and can boost and encourage roof-top solar which would be much more economical for e-bike users. One or two panels without an inverter might be a good package for DC systems. A subsidized elec-tricity tariff for e-bikers in off-peak periods may

also be considered. Another market for EVs are trucks and buses. These vehicles consume high volumes of diesel. These are expensive operating in a tough and competitive market. These would also require a well-spread charging network. Recently, the Sindh gov-ernment bought a fleet of buses for Karachi's public transport network. Authorities have installed

charging infrastructure in bus garages. For a gov-ernment, upfront costs which may be as high as \$300,000 may not be as big an issue as it may be

for the private sector. International subsi-dized financing lines can be found for financing EVs. The conversion of diesel buses can be a viable approach since diesel engines are to be replaced every five years. At this replacement juncture, the conversion of diesel buses to the EV system may be a feasible approach. Only institutional operators may be able to own and operate EV buses due to the issue of expensive charging

infrastructure.

If one starts with an initial production rate of 175,000 units per year with a growth rate of 10 per cent per annum, one would get the annual sales of 341,000 units. It is much lower than the required sales of 2 mil-lion per year by FY 2030 (50 per cent market share of e-bikes). One would have to start with an initial production of 400,000 units per year with an annual produc-tion growth of 25 per cent per annum to be able to get the required production rate of 2 million units per year. More aggressive policies may have to be designed in the mid term to achieve these targets. This shows that it may

not be feasible to achieve the 2030 target of a mar-ket share of 50 per cent in new e-bike sales. It may be worthwhile to explore other policy options as well, such as conversion of the existing motorcy-cles to e-bikes; it costs Rs50,000 for one such conversion. These rates may go down if the mar-ket expands. Many countries, including Indonesia, have made conversion a have made conversion a part of their policy pro-gramme. In India, con-version is being pursued in the bus sector; one conversion costs INR6 million. There are plans in Karnataka to convert 30,000 diesel buses to e-buses by 2030

India has 200 million plus motorcycles. In FY2022, 231,338 units of e-bikes were sold. In India and Indonesia – two countries with a large ebike market - there are 10-12 e-bike manufactur-ers. Contrary to this, in Pakistan, with a much smaller market, licences have been issued to 23 companies for e-bike manufacturing It would certainly reduce the indi-vidual market shares of manufacturers to an uneconomical capacity. While companies may be making profits, the goal of 90-100 per cent local manufacture will remain elusive if this trend conlicence holders may not

Given the fact that Pakistan has all kinds of rent-seeking and corrupt elite, it is only democracy that ensures some form of accountability of the political class through elections every five years. The non-political technocratic elite is not accountable to anyone.

Democracy has a feedback loop built in the system. The political class has to take into account the public aspirations since it has to seek votes to come to and remain in power. Any technocratic setup has no such compulsions. Therefore, a government without accountability is a non-starter. The poor in the country

are hugely disempow-ered. The bureaucratic, legal, judicial, socio-political, and economic system works against them and is mostly alien to them. The poor only have the power to vote that they can leverage to get a pittance of favourable terms for themselves. Endorsing any idea for technocratic setup is equivalent to snatching the last vista of empowerment of the poor

from them. The much-condemned political patronage sys-

tem is sometimes the only refuge the poor have to negotiate their way with state institutions. Social science literature has shown time and again that the poor use their power of vote and politics of patronage to deal with thana/katchehry' other government institu-tions. Any technocratic setup cannot deliver for the poor the way democracy does.
It is true that though

democracy largely deliv-ers for the people, it should not be so populist that it becomes the slave anti-rational sociopolitical and economic policies - an example being the government's inability to tax traders as political parties are afraid of the power of the trader class and are unwilling to bear the political cost of antagonizing them in elections. As a result, politicians do not tax hem, and this is bad for the country's economy. However, such shortsighted policies are not limited to democratic governments; traders have never been taxed by authoritarian regimes in Pakistan as well. It shows the problem is not democracy that can be fixed by the mirage of any technocratic setup, the malaise is deeper than

Turkey's next general election was officially due on June 18. "This is not an early election but bringing it forward," Erdogan said during the video

broadcast shared by his office. The Turkish leader said that they had agreed on an adjust-

they had agreed on an adjust-ment to the timetable with its junior right-wing coalition part-ner to avoid disrupting the school exam schedules.

Time ticking The election campaign is due to start on March 10, which would give the Turkish opposition even less time to prepare. They have been trying for months to agree on a trying for months to agree on a single candidate to challenge Erdogan at the polls. While Turkey's high inflation and weakening currency could help their cause, internal disagreements also to Erdogan's from ments play to Erdogan's advan-tage. He has been using the gov-ernment's dominance in the media to control the nation's political debate. An opposition party source told this week that their joint candidate would be announced in February.

Istanbul's popular opposition mayor Ekrem Imamoglu is a favourite in opinion polls, which suggest he could beat Erdogan in a head-to-head race. It was he who put an end to the domination of Erdogan's ruling party in the 2019 local elections.

An Istanbul court last month banned the 52-year-old from politics, but he has appealed and can technically run for presi-

Imamoglu's legal battle has turned the main opposition CHP party's leader Kemal Kilicdaroglu into the most likely candidate to stand against Erdogan.

ISLAMABAD: Framing policies to boost the economy without transforming the agriculture sector is of no benefit. Pakistan's agricultural landscape will change as a result of research, technology, and innovation, enabling farmers to become more knowledgeable and competitive.

Talking to WealthPK, Muhammad Azeem Tariq, an expert at the National Agricultural Research Centre (NARC), said, "In rural areas, approximately 68% of the population depends on agriculture for food and livelihood.
