The Supreme Court will announce its verdict on the PTI's petition challenging the Election Commission of Pakistan's (ECP) decision to postpone polls to the Punjab Assembly till Oct 8 on Tuesday (tomorrow) (tomorrow).

A three-member bench — comprising Chief Justice of Pakistan (CJP) Umar Ata Bandial, Justice Ijazul Ahsan and Justice Munib Akhtar — reserved the judgment today after hearing all the parties, including the government, the PTI, the ECP and others. However, it did not hear the counsels of the coalition parties.

judges of the original five-member bench — Justices Jamal Khan Mandokhail and Aminuddin Khan — recused themselves from hearing the case. Thereafter, the CJP con-stituted a bench comprising himself, Justice Ahsan and Justice Akhtar to proceed with the PTI petition. the PTI petition.

Earlier today, the govern-ment submitted a statement through Attorney General for Pakistan (AGP) Mansoor Awan, requesting the formation of a full court to hear the case. It also sought the dismissal of the PTI petition in the light of what it interpreted as a "4-3" order issued by the apex court on March 1.

The apex court, had in a 3-2 verdict, ruled on March 1 that

'Government cannot boycott proceedings'

AGP Awan, ECP lawyers Irfan Qadir and Sajeel Swati, PTI lawyer Ali Zafar, and PPP counsel Farooq H. Naek were present in the courtroom as the hearing commenced today. The secretaries of finance and interior ministries were

and interior ministries were also in attendance.

At the outset of the hearing, Naek came to the rostrum. Justice Bandial asked the lawyer if PPP had ended its boycott against the court hearing to which the latter replied that he had not boycotted the proceedings.

"How can you boycott [the hearing] on one side and also attend the hearing on the other hand," Justice Akhtar wondered. "For the last 48 hours, the media has been saying that

political parties have expressed no confidence in the bench.
"How will you present your arguments if you don't have confidence in us?" the judge asked and then stated that the court would only hear Naek if he withdrew the statement -jointly issued by coalition leaders last week expressing "com-plete no-confidence" in the bench.

'Only court has authority to delay polls'

Subsequently, AGP Awan began presenting his argu-ments. The lawyer highlighted that the PTI petition was based on the SC's March I verdict, in which the apex court had instructed the president to select a date for elections in Punjab and the governor to pick a date for polls in KP. But the KP governor never selected a d ate until the petition was filed, he pointed out "The question is how can the ECP give the date of Oct 8 for polls," the CJP said here.Web Desk

CPDI urges CM Balochistan to form information commission

QUETTA: The Centre for Peace and Development Initiatives (CPDI) has called upon the Chief Minister of Balochistan to appoint members of the Balochistan Information Commission, as required by the Balochistan

Right to Information Act, 2021.

The CPDI has emphasized that the establishment of the Information Commission is critical for promoting transparency and accountability in

The Balochistan Right to Information Act was passed by the Provincial Assembly on February 1, 2021, and received the assent of the Governor of Balochistan on February 15, 2021. The Act mandates the Balochistan government to appoint members of the Balochistan Information Commission within 180 days of the commencement of the Act under Section 18(1).

Two years on, the government is yet to establish an information commission

However, despite this legal obligation, it has been more than two years since the passage of this Act, and members of the Balochistan Information



Commission have not been appointed. This delay is a violation of the law and undermines the purpose of the Balochistan Right to Information Act.

Increasing ratio of suicides in Balochistan

In Balochistan, the ratio of suicides continues to increase especially among the women segment of society at an alarming level. Statistics shared by a littleknown Paank, a non-governmental organization about the alarming increase in the number of suicide cases should be an eye-opener for policymakers.

The organization reports 56 suicide cases most of them women during the last three months in Balochistan. Last year, 80 suicide cases were reported across Balochistan. The cases must be higher than what is being quoted by the NGO since most of the cases go unnoticed in rural Balochistan because of social and

Mental stress, social-tribal taboos, unemployment and poverty main reasons

behind the increasing suicides ratio

Mental stress, social-tribal taboos, unemployment and poverty appeared to be
the underlying reasons behind the increasing ratio of suicides. And this phenomenon is not confined to Balochistan rather it is an issue faced by different

Especially, frequent cases of suicides have been reported on social media from Balochistan's Mekran division. A growing number of cases in Mekran, which is considered to be the intellectual capital of Balochistan are disturbing WHO defines mental health as a state of mental well-being that enables peo-

ple to cope with the stress of life The World Health Organisation defines mental health as a state of mental well-being that enables people to cope with the stresses of life, realize their abilities, learn well, and contribute to the community. Mental health is a basic human right, but in the non-urban social setup in Balochistan, mental health

issues that include mental disorders, psychosocial disabilities as well as the risk of self-harm, are generally ignored and not given the right level of importance. In most cases, people commit suicide due to stress and depression to get rid of worldly issues. There have been no proper health institutions to provide

counseling to mentally challenged people.

Physiatry institutes should be established on the district level

The health department established a physiatry institute in the Bolan Medical

Complex Hospital (BMCH) after the hectic efforts of well-known psychiatrist Dr. Ghulam Rasool. However, the institution needs more manpower and facili-ties to treat mentally ill people. Such institutes need to be established on district levels to make sure timely medical treatment/counseling of mentally challenged

It is ironic of fate that mental disorder/stress is hardly considered an illness in our society. People take it very lightly and easily and prefer to avoid psychi-atrists. An awareness program should be launched by the Balochistan govern-ment to create awareness among the people about mental disorders and other

The growing number of employee associations, in the name of their welfare, underscores the growing utility of forming pressure groups to protract spheres of influence. Taking a cue from the past, the growing trend will bring serious pres-sure on the frail institutional framework adding to public griev-

One of the phenomena, engendêred by growing pressure groups in the public, is written writ large that institutions have exponentially grown in size, while at the same time turned into pathetically ossified entities, foretelling their imminent fall. The eventuality

will not only bring about suffering for all employees associated with these institutions but it will also add to the flight of the public at large. The bloated oversize of public departments in association with their age-old calcified nature has turned them into a selfserving superstructure and lost relevance to the common man.

A department created for the general public turned into a service provider for employees only

A department created

for the service of the public turned into a service provider for their respective employees. All the offices at dis-trict, divisional or provincial levels have more affairs related to employees than that of the ones for whose welfare the same are creat-The resources placed at the disposal of these institutions with the aim to alleviate the issues of citizens, are arrogated to themselves and have turned into a

bone of contention for members of the institutions. Speaking of personal experience of a department, with dis-trict and divisional level offices, it was noted that more than 90% of the correspondence made with that office was related to the personal affairs of the employees working in that department. It is the case with public sector every public sector institution. Their raison d'etre is service unto

Element of powers keep their opponents at bay

The element of powers among employees' associations also include larger size, the larger the size, the more nuisance value to keep the opponent at bay. At the provincial secretariat with the aim to enlarge its own size decades-old clerical staff positions are exponentially expanded leading to a 'one size fits structure. Despite specialization in every field turning into a norm, the public sector is stuck in an age-old management model. The information technology devel-

opment has turned the public sector structure into an obsolete entity. The manpower and the machine have found no compatibility. The only change in the last 75 years is that number of positions has shifted from one service group to another. Mutual bargaining among the service groups is termed reform in the system. A thirdbody assessment guided only by the public interest has never taken place. The resistance to cha nge has not only left the

public sector unworkable, the private sector has overtaken it in the market. When private sector services are required from the market, the public sector functionaries are found totally clueless about the trend in the market. Res ultantly, the public sector is uniformly characterized by sub-standard qua lity. The public sector has still not parted from the role, long performed by it but is now overtaken by t he private sector with b etter performance. A rol e swap from a player to a r egulator has still not tak e n place. The role of regul ator, which should have b een taken by the public s ector, is distasteful for it. The author is a serv-

has also increased. The commercializa-tion of space has created new opportunities for from businesses launching satellites to mining asteroids and other celestial bodies for valuable resources. The benefits of space exploration and its uses are manifold, and global powers are investing in this field to explore its potential for scientific and economic advance-

According to a report y the Space Foundation, the global space industry generated revenues over \$469 billion in 2021. With its skilled workforce and expertise in science and technology, Pakistan is gradually making efforts to explore this dimen-With increasing private investment in space-tech, startup technologies to ease move-ment and communications, it is high time investment in the space industry.

Pakistan was among the first 10 countries to start a space programme

ship of the late Nobel Laureate Dr Abdus Salam, as chairperson of Space Upper Research Atmosphere Commission (Suparco). The progress in harnessing space technology has however been rather slow. Much of the criti-cism goes to the politicoeconomic uncertainties and periodic financial crunches that Suparco had to face soon after the successful launch of the satellite 'Rehbar-1' on June 7, 1962. However, in an increasingly fragile global environment where the space arena lawless, remains Pakistan can no longer remain oblivious to the expanding commercial space activity

information for disaster preparedness.

Pakistan is already using space-based technologies to monitor and its water manage resources and assess water quality. It can assist to develop better water management strategies and ensure sustainable use of water resources. Agriculture is backbone Pakistan's economy, employing over 42.3 per cent of the country's labour force and it contributes 18.9 per cent to GDP. The use of space-based technologies such as remote sensing is agricultural productivity in the country. Satellite data, there-

fore, can be applied to better crop health, estimate crop yield, and assess soil moisture. Likewise, Pakistan can also use space-based technologies to monitor its forests and wildlife by employing a combinaremote sensing and satellite imagery These technologies can help identify areas that need protection, moni-toring changes in land use, and planning conservation measures to ensure the long-term sur-vival of forests and wildlife populations.

As per some reports by USAID, 50-75 per cent of all court cases in Pakistan are related to land disputes. Will our media find time for these useful debates about the very future of our people or continue to get bogged down with silly shouting matches of 'he said he

A cursory look at world history tells us that nations have experienced the worst times of their history including wars and great depression before but only countries with wise leadership and foresight have sailed through During these depressing times, people with resources to survive have to help other people. That will help a country from going down a spiral of anarchy. People around the world have stood with

So can we. Will we? Will our power elites open their wallets and hearts to help the people of their own country to survive this troubling time?

We have seen countries disappear from the world map despite the mighty military power they used to have. The Soviet Union and Yugoslavia don't exist today. This happens also when reli-gious, linguistic, ethnic and cultural diversity is not treated as a strength. The same diversity becomes your death war-rant if you don't appreci-ate and celebrate it.

Pakistan continues to develop the population time bomb with every passing day. With no resources available to develop human resources, we continue piling up large crowds of ignorant, unskilled and unhealthy people. inhealthy people. To survive and prosper

That Pakistan is in a profound economic and political crisis is no longer in dispute. Most observers and economists are united in that opinion. What to do about it is less clear. The Chinese character for risk is closely related to opportunity, which is more accurately defined as a 'crucial point when some-

thing begins to change'.
Will it? We hope so. This article is more about 'what' needs to change.

about 'what' needs to change.

There are two distinct thoughts about the current economic crisis. One: adjust now, stabilize the economy and then restart the growth process. Let us call this the traditional view. This thinking underlines the IMF programme: let the exchange rate be determined by reader forces. mined by market forces, curtail expenditures, increase taxes and so on. Each time this logic has been followed, the subsequent growth spurt hits the foreign exchange barrier with the under-performing export sector seen as the basic culprit. Technical discussions abound about export subsidies being inefficient, and/or the need to revamp the export sector, especially textiles.

sector, especially textiles.

The second approach, less successful of late, is to rely on the largesse of friends—China, UAE and Saudi Arabia. And, in earlier days, the USA. The thinking being that the country can scrape through without major structural changes in the Pakistan economy or in the ability of the ruling elite to maintain their global lifestyles.

their global lifestyles. The government has tried hard to pursue a mix of the two strategies, but it has become abundantly clear that the IMF option is the

only option left.
Will that be enough? Will that lay the base for future prosperity? Will that shift the econ-

omy and society in 'putting people first'?

A quick review of successful development experiences, including South Korea and China, highlight some deeper more critical factors than just macroeconomic issues of balanced budgets and higher tax-to-GDP ratios. These include: a determined long-term policy perspective since development is all about transforming society and the economy; enhancing capabilities, by investing in people, and, by recognizing that social policy is as important as economic policy in this trans-

One, establish (and adequately fund) effec-tive public education and health systems. No

country, bar none, has succeeded in develop-ing without a functioning public education

In a land with little social protection, pur-suing universal health coverage with a focus on the poor is the right step to take now.

There are structural and funding issues which need to be urgently addressed for both subjects. Current income support programmes for instance not only need to be substantially enhanced but have to be condi-tioned on enhancing capabilities.

Two, fix the agricultural sector. First, tax agricultural income, especially since almost 70 per cent of the land is in the hands of large

and medium farmers.

It is a myth (and little evidence) to argue that large farms are more productive than small farms. A cursory look at why East Punjab has done so much better than West Punjab shows that structural changes (land reforms) and incentives (and more educated next generation farmers) are at the heart of

the differences.

If 'putting people first' is our defining slogan, then it is time to support small farmers (defined as less than 7.5 acres) which form 78 per cent of farmers and 32 per cent of total farm area. Start by reallocating state land to poor farmers, with strong technical support for seeds, fertilizer, and advice.

Initiate and scale up a Rural Employment Guarantee programme, enshrining the core

the differences.

Guarantee programme, enshrining the core idea of employment as a basic right. And, through this, provide a necessary injection of purchasing power into the rural economy, especially for the landless and those affected by the floods.

Three, restructure the export sector. Without getting into a long debate about subsidies, set up a five-year transition plan on a subsidy draw-down, with an agreed structural transition and diversification towards high value added, knowledge intensive exports. Many innovations are possible. Take the example of Ethiopia, a non-oil producer, which set up a \$150 billion sovereign wealth fund, seeking investment for state-owned enterprises and assets as the government

Five, get rid of an open capital account. Countries like China with \$3 trillion reserves have not opened their capital accounts. Why has Pakistan kept the capital account open for so long? Open accounts limit domestic policy autonomy and can deeply disrupt domes-

tic production arrangements.

A comprehensive study about trade and financial liberalization for the 2014 Global Human Development Report concluded that 'opening up' benefits developing countries only when their human capabilities are high Later studies have reconfirmed this essential point. Even in the EU accession process, less advanced countries like Romania and Bulgaria have tried to argue for selective capital controls

There has been some talk in Pakistan about a one per cent economy. But a deeper con-cern is about a Pakistani elite, which feels as global as any, able to travel and co-exist in UK, US and Dubai spaces. Indeed, many Pakistani business operators tend to have a business base overseas as well. Even experienced Pakistani economists have tended to consider western practices in looking at cur-rent policies, rather than critically examining what has worked in other developing countries and applying those lessons to Pakistan. For a 220 million country we appear to be driven by the needs and values of a few milon people at the most.

Six, fiscal space: It goes without saying eliminate all the special SROs, and the associated giveaways (unearned incomes or rents). The last National Human Development Report (for Pakistan) estimated an annual cost of \$70 billion dollars in these legal giveaways to the elites, which contrasts with half that estimated amount for corruption. Just stop!

Rethink the centre-province fiscal arrange-ments, set 'checkable' development stan-dards for expenditures which may also minimize political largesse, and require provinces to raise their own tax revenues as matching funds.It could well be, as has been argued elsewhere, that these steps may not be enough and that a deeper fiscal surgery is now required. There is talk of reducing non-combat military expenditures. What needs to be kept in mind in this regard is that only the government in consultation with the nation's military has the sovereign right to determine the details regarding the financial operational capability of its forces. Not the IMF.

mran Khan has forwarded a 10-point agenda to steer the economy out of the exis-tential crisis that Pakistan faces. This is welcome, since the government appears to be clueless on the steps required to address the issues - other than to seek more loans from all and sundry.

The plan contains three strands: curtailing the current account deficit, increasing the tax net to raise revenues, and promoting development in various socio-economic sectors. An assessment is

in order.

The first part revolves around 'bringing in dollars', which includes motivating overseas Pakistanis to facilitating country, facilitating exports and promoting tourism. The second part is just that: 'increasing the tax net to generate revenue. And the third part covers development of IT, tourism and mining, raising agricultural productivity, restructuring state-owned enter-prises, and providing the youth with interest-free loans to take business initiatives.

The above roster appears to be an offhand attempt to throw in an assortment of ideas and call it a plan. There has not been a coherent development plan for over 40 years now, how-ever, the PTI economic management has been even more garbled and the present 'plan' more unfocussed. IKnomics, like Daronomics, has proved to be a bad dose of quackery in the past and threatens to continue to be so in the future as well. Pious pontification cannot be a substitute for sound policy manage-

More seriously, the regular dose of terror attacks, honour killings, forced conversions, etc that Pakistan spews forth for the international media cannot serve as a welcome mat for tourists.

The part about increasing the tax net to enhance revenues is again just a repeat of the hackneyed position that international creditors and donors have been churning out. The FBR has, over the last three decades, resorted to the harshest of measures to squeeze revenues out of a stagnant economy and more of the same is unlikely to deliver. What is required is reduction of non-debt current expenditure, including non-combat defence expenditure Part of the resultant fiscal savings should be diverted to retire part of the out-standing debt to reduce the annual debt servicing burden. 
