News Desk: QUETTA: In a decisive operation following the Jaffar Express inci-dent, Pakistan's security forces have successfully rescued all hos-tages while neutralizing 33 terros-ists responsible for the attack. Despite these challenges, the security teams prevented any additional casualties by swiftly countering the suicide bombers, who had attempted to use explo-sive vests while positioning vul-nerable passengers as human shields.
